Nigeria: The GCON has previously been awarded to Queen Elizabeth II in 1969, making Mr. Modi the second foreign dignitary to receive this prestigious honour. In a significant move to strengthen diplomatic ties between Nigeria and India, President Bola Tinubu has conferred the Grand Commander of the Order of the Niger (GCON) upon Indian Prime Minister Narendra

Arrested actress Kasthuri brought to Chennai from Hyd, remanded in judicial custody

Chennai South Indian film actress Kasthuri Shankar, who was arrested in Hyderabad last night for her alleged derogatory remarks against Telugu speaking people living in Tamil Nadu, was brought to Chennai on Sunday and remanded in judicial custody.

A special team from Chennai, which arrested Kasthuri after her anticipatory bail plea was dismissed by the Madurai Bench of the Madras High Court on November 14, obtained a transit warrant from a Hyderabad court, and escorted her to Chennai on Sunday after-

After preliminary interrogations at the Chintadripet All Women Police Station in Chennai, she was produced before an Egmore Magistrate Court at his residence. who remanded her in Judicial custody till November

It may be recalled that Mr Justice N.Anand Venkatesh of the Madurai Bench of Madras High Court had on Thursday dismissed her anticipatory bail petition filed by the actress apprehending arrest in the case relating to her alleged derogatory remarks against Telugu community in Tamil Nadu on November three during a protest demonstration in Chennai on Brahmin Rights and opposed alleged dis-

Yet another complaint was also filed at the Thirunagar police in Madurai which had registered a case against Kasthuri for alleged offences under Sections 196(1)(a), 197(1)(c), 296(b), 352, and 353(3) of Bharatiya Nyaya Sanhita (BNS) based on a complaint from the members of Tamil Nadu Naidu Mahajana Sangam. The Sangam in

a petition to the Commissioner of Police, Madurai city on November 5, alleged that the remarks made by Kasthuri against the Telugu speaking community and women were demeaning and disturbs the social fabric of the State. Her comments amounted to dividing the community in Tamil Nadu, stoking racial hatred and causing concern to people of the Naidu community.

Apprehending arrest in the case, the actress moved the Madras HC Bench seeking anticipatory bail.

In her petition, Kasthuri said she had already issued a public apology and that her comments were specific to certain individuals and not directed at the broader Telugu community. The cases were filed against her due to political pressure.

She further stated that no riot or provocation had happened among any members of the society over her comments and she had been receiving support from the different quarters of the Telugu people across Tamil Nadu, Andhra Pradesh and Telan-During the course of

hearing of her plea, the court remarked that her comments were unwarranted and she should have refrained from speaking against the women of the Telugu community. Her apology does not address the comments made against the Telugu speaking women, the court said.

Cases were also registered against the actress by the police at Tiruchirapalli and Coimbatore by the members of Tamil Nadu Naidu Mahajana Sangam.

DRDO carries flight-trial of long-range hypersonic missile off Odisha coast

Research and Development Organisation (DRDO) conducted a successful flighttrial of India's first longrange hypersonic missile from Dr APJ Abdul Kalam Island off the coast of Odis-

This fright-trial of hypersonic missile that was conducted late Saturday is designed to carry various payloads for ranges greater than 1,500 km for the Armed Forces, an official statement said on Sunday.

The missile was tracked by various range systems, deployed in multiple domains.

The flight data obtained from downrange ship stations confirmed the successful terminal manoeuvres and impact with a high degree of accuracy.

This missile has been

According to a press release issued by the Madurai division of the Southern Railways on Sunday, the complaint was given by a passenger travelling in Coach C2 of the train at 0800 hours, shortly after the train departed from Madurai.

The food, supplied by Tirunelveli-based kitchen managed by M/s Brindavan Food Products, was inspected immediately by the onboard manager, Chief Catering Inspector, Chief Commercial Inspector and Assistant Commercial Manager.



The insect was found stuck to the lid of the casserole container, appearing uncooked, suggesting possible post-preparation contamination.

The railway officials apologised to the passenger, assured strict action against the licensee, and arranged an alternative

meal from Dindigul railway station, which the passenger declined.

461 women have been elected to the Maharashtra Assembly since its establishment in 1957, the Election Commission said on Sunday.

In Britain, America, and many other countries, women voters have fought for their right to vote for one hundred and fifty years, and then they have got that right.

According to the 2011 census, there are 929 women for every 1000 men (Gender Ratio) in India. As against that, in 2019, the number of women on the electoral roll for every 100 men was 925. Special campaigns for women voter registration were carried out to increase the number, and thus, the number improved significantly to 936 in 2024.

Total 9,70,25,119 voters have been registered in Maharashtra for the Vidhan Sabha General Election -

Of them, male voters number 5,22,00739 and female voters are 4,69,96,279.

chilly -5.3°C, Gulmarg at -1.8°C, and Pahalgam at -2.0°C, recorded their season's lowest temperatures on Sunday, following fresh snowfall in the higher reaches of the Kashmir valley on Saturday. The tourist destina-

tions of Sonamarg in Ganderbal, Gulmarg in Baramulla, and Pahalgam in Anantnag, along with other higher reaches of the Kashmir valley, received snowfall while the plains were lashed by rains on Saturday, resulting in the dip in temperatures.

The minimum temperature during the intervening nights of Saturday and Sunday at Sonamarg was recorded at -5.3°C, Gulmarg at -1.8°C, and Pahalgam at 2.0°C, the first lowest during this season.

However, the night temperature in other weather stations of the Kashmir valley was recorded at 0 to 4°C above

The day temperature in all the weather stations of the Kashmir valley also dropped by 2–9 °C on the previous day.

Srinagar, the summer capital of Jammu and

Kashmir, recorded the maximum temperature at 12.2°C on Saturday, and it was 3.7°C below normal.

The weather improved on Sunday, and the sun appeared in Srinagar and other parts of the Kashmir valley and is likely to remain dry till November 23, the MeT office said. Govt opens bus depot with all-women

New Delhi :, Transport minister Kailash Gahlot on Saturday inaugurated the world's first all-women bus depot, named 'Sakhi Depot', in Sarojini Nagar, govt said in a statement.Officials said the depot boasts a 223-strong female workforce, comprising 89 drivers and 134 conductors, operating a fleet of 70 buses-40 airconditioned and 30 nonair-conditioned-serving 17 routes across Delhi, apart from other administrative, maintenance, and support staff. "It is part of a broader vision to create a more inclusive and gender-equal work environment," the statement read. During the inauguration, Gahlot highlighted the significance of the depot as a symbol of breaking barriers in traditionally male-dominated fields and as the first step in a series of such initiatives under the 'Sakhi' programme aimed at expanding opportunities for women in public transport. He said establishing the Sakhi Depot required overcoming several challenges, including revising the minimum height requirement for drivers from 159 cm to 153 cm to make the role accessible women."Buses were also modified with features like power steering and adjustable seats to facilitate female drivers and to support training and licensing. Delhi govt launched the 'Mission Parivartan' programme in April 2022, providing free training for aspiring women drivers," the statement further said.

Kailash Gahlot Resigns: BJP Calls It 'Courageous Step' Amid AAP's Allegations of 'Dirty Politics and Conspiracy'

New Delhi : On Sunday, a political upheaval occurred when senior Aam Aadmi Party (AAP) leader and Delhi minister Kailash Gahlot resigned from the party. The Bharatiya Janata Party (BJP) praised his departure as a courageous act, while AAP accused the BJP of engaging in "dirty politics and conspiracy" to pressure Gahlot into quit-

In his resignation letter, Gahlot expressed disappointment with the pardirection, citing internal issues and a shift away from public service toward political ambition. He also criticized AAP for not addressing problems like the pollution of the Yamuna River and suggested that scandals like the "Sheeshmahal" incident had damaged public trust in the party.

Delhi BJP President Virendra Sachdeva lauded Gahlot for revealing the shortcomings of the AAP



Gahlot has shown Arvind Kejriwal his true reflection and distanced himself from his 'lootera gang.' His decision is commendable," Sachdeva remarked.

BJP leader Nalin Kohli echoed this praise, pointing to Gahlot's critiques of AAP's governance. "His

resignation highlights the worsening pollution in the Yamuna and underscores AAP's failure to meet its promises. The party's governance has devolved into excuses and deflection," Kohli commented.

On the other hand, AAP claimed

Gahlot's resignation was the result of BJP's coercive tactics using central agen-

cies. Rajya Sabha MP Sanjay Singh alleged that Gahlot was targeted by raids from the Enforcement Directorate (ED) and the Income Tax Department, along with accusations of corruption amounting to Rs 112 crore.

"Gahlot had no choice but to resign. The BJP's conspiracy and misuse of the ED and CBI forced his hand," Singh asserted.

AAP spokesperson Priyanka Kakkar supported these claims, stating, "Gahlot likely chose the BJP over imprisonment. Just hours before his resignation, he was still active within AAP. The pressure is evident." Delhi Chief Minister

Atishi has accepted Gahlot's resignation, which occurs just months before the capital's assembly elections. This event is expected to influence political narratives as both parties ramp up their cam-

Hospitals deny free treatment to acid attack survivors in Delhi

New Delhi : Violating the Supreme Court's 2015 guidelines mandating free treatment, including medicines and corrective surgeries, for acid attack survivors across the country, Delhi's private hospitals continue to charge these patients.

While NGOs extend monetary assistance to survivors to meet treatment costs, the latter find the going extremely tough when these expenses exceed established limits. Consequently, they are compelled to approach

Two such acid attack survivors, Ruman and Priyanka, went to court after a prominent private hospital in the capital allegedly refused them admission in 2019 and 2023, respectively.

In an order in the case of Priyanka, the high court sent out the message that all expenses, including those for surgeries and medicines, would be covered by the hospital. Although the hospital subsequently admitted these patients and provided treatment, they remain unwilling to offer follow-up care for

free without legal interven-

Priyanka (30), who was allegedly forced to consume acid by her husband in 2017, has alleged that she was asked to pay Rs 5,000 for medicines on Oct 31 this

She said she noticed a distinct change in the attitude of the hospital staff when they learnt that they had to provide court-mandated free treatment to her. She claimed that the staff insisted on partial payment, demanding half the amount. However, after her lawyer intervened, the hospital withdrew that demand.

Priyanka, whose diges tive system is severely damaged, claimed that during each hospital visit, she is now forced to involve her legal counsel since the staff denies assistance without such intervention. Visibly distressed, she said she is mentally and physically drained.Ruman, 26, is receiving treatment at the same facility and has voiced similar concerns about insufficient medical care.

Arvind Kejriwal Asked About Kailash Gahlot's Shock Exit

conference held to welcome former BJP MLA Anil Jha into the Aam Aadmi Party (AAP), national convener Arvind Kejriwal declined to address a question about Delhi Minister Kailash Gahlot's unexpected resignation. When asked about Gahlot's departure, Kejriwal redirected the microphone to senior party leader Durgesh Pathak. Despite the reporter's insistence, Kejriwal deflected, saying with a smile, "You want an answer, right?" before Pathak began speaking. Kejriwal then criticized the BJP without mentioning Gahlot's resignation.

Pathak explained that Gahlot had been under investigation and faced raids by the Enforcement Directorate (ED) and Income Tax authorities for months. "He had no choice but to resign. This clearly indicates that the BJP has already lost the Delhi election. They have no substantial issues and are relying on ED, CBI, and Income Tax investigations, while we focus on people's issues," Pathak stated.

Earlier, AAP's Rajya Sabha MP Sanjay Singh described Gahlot's resignation as part of the BJP's "dirty



politics." Singh claimed that Gahlot was pressured through ED-CBI raids and was acting according to the BJP's script. He accused the BJP of using what he called the "Modi Washing Machine" to force opposition leaders to join them, a tactic frequently mentioned by opposition parties to describe coercive measures employed by the BJP.

The AAP's response me about an hour after Gahlot posted his resignation letter on social media. In the letter addressed to Kejriwal, Gahlot, who handled key portfolios such as Home and Transport, highlighted significant internal

challenges within AAP. He criticized the party for prioritizing political ambitions over public commitments. citing the unfulfilled promise to clean the Yamuna River, which remains heavily polluted.

Gahlot's letter also took an indirect swipe at Kejriwal, referencing "many embarrassing and awkward controversies," such as the "Sheeshmahal" scandal, a term used by the BJP to criticize the renovation of the Chief Minister's residence. He questioned whether AAP still upheld its principles as the party of the common man and accused it of focusing more on its political agenda than on delivering basic services to Delhi

Stating that his political journey began with a commitment to serve Delhi's people, Gahlot expressed his disillusionment and resignation from AAP's primary membership, wishing Kejriwal well for the future.

A lawyer by profession, Gahlot represents the Nazafgarh Assembly constituency and has been a cabinet minister since 2015. He also took on the finance portfolio following former Deputy Chief Minister Manish Sisodia's arrest in a corruption case last year.

The BJP quickly responded to Gahlot's resignation. Party spokesperson Shehzad Poonawalla remarked that Gahlot's letter exposed how the "Aam Aadmi Party has become the Khaas (special) Aadmi Party," accusing them of breaking promises and prioritizing self-interest. Delhi BJP chief Virendra Sachdeva praised Gahlot's "bold step," suggesting it proved even AAP insiders believed Kejriwal misused public funds. Delhi air pollution: City's AQI remains in 'severe' category for 5th consecutive day

New Delhi: The air quality in the national capital remains a concern as the Air Quality Index (AQI) stays in the 'severe' category for the fifth consecutive day on Sunday

The overall AQI of Delhi stood at 428 in the 'severe' category at around 7.30 am., as per the Central Pollution Control Board (CPCB). CPCB data showed that most

areas reported air quality in the severe category, with AQI levels above 400. Key locations recorded severe

pollution levels, including Anand Vihar at 457, Ashok Vihar at 466, Aya Nagar at 426, Bawana at 471, Dr. Karni Singh Shooting Range at 415, Dwarka Sector 8 at 445, and Dilshad Garden at 448.

Other areas showed similarly alarming figures: 411 at ITO, 466 in Jahangirpuri, 419 near Major Dhyan Chand Stadium, 434 on Mandir



Marg, 463 in Mundka, 402 in Najafgarh, 444 in Narela, and 442 in Nehru Nagar.Further hotspots included North Campus DU at 427, NSIT Dwarka at 410, Okhla Phase 2 at 409, Patparganj at 439, Punjabi Bagh at 442, Pusa at 407, RK Puram at 434, Rohini at 449, Shadipur at 457, Siri Fort at 405, Sonia Vihar at 440, Vivek Vihar at 454, and Wazirpur at 463. The hazardous pollution levels are triggering serious health issues, including respiratory problems, eye irritation, and an elevated

risk of cardiovascular diseases. According to the Central Pollution Control Board (CPCB), over 14 locations in Delhi recorded AQI levels exceeding 400 on Sunday.

Visuals from the city reveal dense smog blanketing the skyline.

In response, the Delhi government has enforced a ban on BS-III petrol and BS-IV diesel four-wheelers under the Graded Response Action Plan (GRAP-III) to curb emissions. The restriction came into effect on Friday and aims to mitigate the worsening pollution levels.

As per the government directive, violators will face penalties under Section 194(1) of the Motor Vehicle Act, 1988, which includes a fine of Rs 20,000.

The Commission for Air Quality Management (CAQM) ordered the activation of GRAP-III across Delhi-NCR on Friday at 8 am, following a sharp spike in pollution levels that pushed Delhi's AQI into the 'severe' category. This measure seeks to prevent further degradation of air quality in the region.

Politics of 370!

There is no reason for anyone to oppose the abrogation of Article 370 in Kashmir. The matter was passed in Parliament after the Assembly was dissolved. The Supreme Court upheld it. Therefore, the wheels of time cannot be turned back now. Political parties in Kashmir know this; but they are happy to politicize this issue. A glimpse of that has been seen recently. Despite knowing that trying to achieve something that is never possible is a waste of time and foolishness, political parties continue this drama to show the people. However, the people are very smart and patient. Once they decide, they teach the good guys a lesson. Article 370, which gave special status to Kashmir, was like a lion without teeth and mane. There was no reason for anyone to oppose it because it was abrogated. The government has to take a policy decision; moreover, the Supreme Court has also upheld it. Therefore, the wheels of time cannot be turned back now. The repealed article cannot be re-implemented and special status cannot be given. It is not that the regional parties in Kashmir are unaware of this; but even though the BJP opposition has expressed displeasure after the political parties took pleasure in politicizing this issue and revoked the special status of Kashmir, now Kashmir cannot be given special status again. For this, a government with a full majority at the Centre and the approval of fifty percent of the states will be required. Therefore, it will not be possible for the opposition to go through this complicated process. It is known that the regional parties in Kashmir have no chance of winning more than three-four seats in the Lok Sabha. It is not possible to say how long it will take for the Congress and its allies to get a majority in the Lok Sabha. In this situation, what Union Home Minister Amit Shah says that even after four generations of Rahul Gandhi, Sharad Pawar and Uddhav Thackeray, they cannot give special status to Kashmir is happening here.

The recent ruckus in the Kashmir Assembly is for two reasons: 'How much effort we are making for a special state for Kashmir and we will not allow the concept of 'one nation, one flag' to be touched in India.' In fact, after the assembly elections, the new Omar Abdullah government of Jammu and Kashmir passed two resolutions in the assembly. The first resolution demanded full statehood. All parties agreed to it. The second resolution demanded the withdrawal of Article 370. There was a constant uproar in the assembly over this resolution. Basically, a resolution is not a law. The second issue is that the Kashmir Assembly does not have the authority to grant special status to Kashmir. In such a situation, if the proceedings of the new assembly are being stalled on this issue, it is not right. There were no people's representatives in the assembly for the intervening six years. Now that the people's government has come, the keys to this government are in the hands of Delhi. In such a situation, instead of wasting time by fighting, the MLAs should have paid attention to how the development of Kashmir, which has stalled in the last few years, can be restored with patience and discussion; But instead of the interests of the Kashmiri people, the MLAs there seem to be interested in mere chaos and chaos. These MLAs should be aware that the people of Kashmir have sent their representatives to the Assembly to raise their basic issues. It is natural for the BJP MLAs to oppose the demand to re-implement Article 370. It was unthinkable for the ruling NCP and Congress MLAs to get into a fight because of what they

Deputy Chief Minister Surinder Kumar Chowdhury moved the proposal to re-implement Article 370 in the Jammu and Kashmir Assembly. The National Conference very cleverly used signals to select the mover of this bill. Chowdhury is a Hindu and has been elected from Nowshera in Jammu. If Article 370 cannot be re-implemented, then the question arises as to why the new government of the Union Territory passed a resolution in the Assembly. Article 370 cannot be re-implemented in Jammu and Kashmir. The decision of the central government in this regard has been approved by a five-judge bench of the Supreme Court. The court mentioned several facts in its decision. It is evident that even after the resolution is passed, the consent of the central government and the President will be required to re-implement Article 370. No matter who is in power at the center, this will not be possible now due to political reasons. Anyone who tries to implement this issue through Parliament and the Pres ident using political power will have to face opposition from the 80 percent majority Hindu community. The cancellation of the two and two symbols has been given the highest approval. The court also said that the government has the unilateral right to amend Article 370. The constitution of Jammu and Kashmir has become inactive due to the implementation of the Constitution of India. The court had also rejected the claim of sovereignty of Jammu and Kashmir.

The BJP government's decision to abrogate Article 370 in 2019 was opposed by regional parties in Jammu and Kashmir, including the National Conference, the PDP, and Congress and non-BJP parties. The Congress also disagreed with the court's decision. Congress leader P. Chidambaram had said that we disagree with the method of abrogating Article 370. After this, many Congress leaders opposed the abrogation of Article 370; but did not say that it would be re-implemented. For the Congress, the opposition to the abrogation of Article 370 is a symbolic ideological fight against the BJP. Therefore, they have promised only full statehood in the Jammu and Kashmir manifesto. This is a political gamble for the 'National Conference' and the 'PDP' to save the people's base in Kashmir. With the approval of the proposal, it is questionable whether the 'National Conference' has started to feel that the promise included in the manifesto has been fulfilled. The 'National Conference' proposal does not mention Article 370. The proposal emphasizes on giving special status. Although the central government has given special status to many states in the northeast, the government is not ready to give such status to anyone new. Andhra Pradesh, Bihar have learned the lesson. The 'National Conference' had prioritized the restoration of Article 370 in its election agenda; but as soon as it came to power, the party changed its tune.

Today, competitive politics is going on in Jammu and Kashmir. Due to political pressure, it was necessary for the 'National Conference' to bring this proposal. In fact, Kashmiris are being misled in the name of 370. Local citizens are raising questions like what problems in Kashmir are there, is anyone monitoring the power crisis in winter? The Abdullah government's proposal has only moral significance. In other words, through this proposal, the state government has tried to tell its supporters that it only wants to fulfill its election promises. The limited powers of the Legislative Assembly of the Union Territory of Jammu and Kashmir, the Assembly cannot do much on issues like restoration of Article 370 and 35 (A), Jammu and Kashmir Reorganization Act 2019. Now only the Indian Parliament has the power to make laws on this subject. The Jammu and Kashmir Reorganization Act will also come in the way of the state government. The Jammu and Kashmir Reorganization Act, 2019 also comes in the way of Omar Abdullah. It gives the Union Territory Assembly the power to make laws on matters other than police and law and order; but at the same time, this act also states that the state government cannot make a law that affects any central law. The approval of the Lieutenant Governor is necessary for the approval or amendment of a bill in the Assembly. Otherwise, it will be considered ineffective. From this point of view, the proposal passed by the Omar Abdullah government to restore Article 370 will remain only on paper until it gets the approval of Lieutenant Governor Manoi Sinha

Farmers protest shortage of fertiliser, seek action against

black marketing Chandigarh : Farmers from several villages in the Kalanwali subdivision have been facing significant challenges due to a shortage of DAP (Diammonium Phosphate) fertiliser. In response, hundreds of farmers gathered at the grain market on Saturday to voice their dissatisfaction and urged the government and administration to ensure an adequate supply of DAP. They also demanded strict action against shopkeepers engaged in black marketing of DAP and urea, and those compelling farmers to purchase additional items along with fertilisers.Farmers including Jaspal Singh, Sukhchain, Gursharan Singh and Jagat Singh, highlighted that while the government claims sufficient DAP supply in the state, the ground reality tells a different story. In Kalanwali, the severe shortage of DAP has hindered farmers' ability to plant wheat and mustard crops. They reported that DAP is being sold at inflated prices, with bags priced at Rs 1,350 being sold for Rs 1,800 to Rs 2,000. Additionally, shopkeepers are reportedly forcing farmers to buy products like zinc, sulphur and nano fertilisers along with DAP and urea. Flying squads to check burning of stubble, garbage in Rohtak

Rohtak: Rohtak Deputy Commissioner Dhirendra Khadgata has directed the officials concerned to strictly comply with the instructions of the National Green Tribunal (NGT) in view of the increasing levels of pollution.

"Three-tier monitoring committees should be formed to monitor the burning of stubble and garbage in rural as well as urban areas. Flying squads should also be constituted to investigate and check such incidents, the Deputy Commissioner said, adding that strict action would be taken against officials found negligent. Presiding over a review meeting at the local mini-secretariat, Khadgata said the departments should register the details of the buildings under construction on more than 500 square yards of land in the urban areas on the government portal.

"All relevant instructions should be followed while demolishing the dilapidated buildings and constructing new ones. The debris should be dumped at designated places. While constructing buildings on



sured that the environment is not polluted," he said. The heads of the government departments were told to ask the contractors to ensure that debris is not left in the open after demolishing a building.

"If any such instance is detected, a fine will be imposed on the department concerned, which will be recovered from the contractor," said the deputy commissioner.

Khadgata asked the DSP concerned to ensure that over 10-year-old diesel vehicles and 15-year-old petrol vehicles in the district are seized at the earliest.

He said water should be sprinkled on the roads as per the guidelines issued by the authorities concerned, but fresh water should not be used for the purpose. Water purified by STP should be used for sprinkling on the roads, he added.

"The officers should also ensure that dirty water is not poured into drains and canals by any vehicle. If any vehicle is found doing so, then the vehicle should be confiscated and a fine imposed on its owner," he said. The Deputy Commissioner said the local municipal authorities should

fix the responsibilities of the employees/officers at three levels to monitor the incidents of burning of garbage etc in the urban areas. He also directed the District Revenue Officer and Block Development and Panchayat Officer to deploy patwaris and panchayat secretaries in every village to monitor the

burning of paddy straw. He instructed Haryana State Industrial and Infrastructure Development Corporation (HSIIDC) officials to ensure compliance with NGT directions by the operators of the industrial units in the district.

Pollution board serves notice to 22 units in Panipat

Panipat: The Haryana Pollution Control Board (HSPCB) has served closure notices to 22 sites, including industries, a bank and construction sites in the district, for the violation of norms under Graded Response Action Plan (GRAP-2). With the dipping temperature, the air quality index (AQI) of the textile city has also started deteriorating. On Friday, the AQI was 343, which is very poor. As per the CPCB, the main pollutants in the air were recorded at severe levels – the PM 2.5 was maximum at 399 while the PM10 was a maximum of 401 in the district.

Apart from this, as the AQI has deteriorated badly in the national capital region (NCR), the Commission of Air Quality Management (CAQM) has implemented the ban orders under GRAP-3 from Thursday onwards. The HSPCB has launched a special drive in the district after the CAOM implemented the GRAP. The teams of HSPCB found a total of seven construction sites in the HSIIDC and on the NH-44 which were not registered on

the HSPCB's dust portal.



During the inspection, the HSPCB found several violations, like these were not registered on the dust portal, had not installed the PM 2.5 and PM 10 sensors, not installed anti-smog gun, building material was not covered at the site, dust masks were not provided to workers etc. Following the

violations, the HSPCB has served closure directions to all these sites and also initiated the proceedings for the levving of environmental compensation (EC) on these violators.Apart from the construction sites, the operation of diesel generator sets had been banned in the NCR by the CAOM.

Dense fog throws life out of gear, but beneficial for wheat growers

Sirsa: Dense fog engulfed Sirsa on Saturday morning, reducing visibility to just 2 m and disrupting daily life. Commuters, especially drivers, faced significant challenges.

While the fog also increased the risk of road accidents. Despite these disruptions, farmers welcomed the dew accompanying the fog, which experts say benefits the wheat crop. Transportation services were severely impacted. Several trains departing from Sirsa ran late, including the Kisan Express and Delhi Express.

Over the past three days, long-distance and passenger trains, including superfast services the Gorakhpurbound Gorakhdham Superfast and the Jaipur-Bathinda train, have been running hours behind the schedule.

Daily commuters have borne the brunt of these delays, struggling to reach their destina-

tions on time. Road traffic was equally affected, with the

Potholes, slush on Ballabgarh-Sohna state highway take toll on commuters

Gurugram : The government's claims on infrastructure and growth fall flat when one traverses the halfa-kilometre-long strectch of the Ballabgarh-Sohna state highway here, which has become a daily ordeal for the commuters. It continues to remain in a shabby condition despite the collection of toll from the commuters. More than 50,000 vehicles reportedly use the highway daily.

"Despite being a toll road, the condition of the passage connecting Ballabgarh and Sohna of Gurugram remains deplorable. No repairs have been taken up in the past about two years,' says Umesh Kumar, a resident, adding that the stretch between Nangla and Pali villages connecting Ballabgarh flyover and Pali T-point, having a length of around 500 metres, is in a poor shape due to the drainage issue. Air quality worsens in Haryana, DCs to take call on suspending primary classes

Gurugram : As the air quality in the state continues to be a matter of concern, the state government has asked the Deputy Commissioners to assess the prevailing situation and to take a call on the discontinuation of physical classes for students up to fifth standard.

In a letter to Deputy Commissioners, the Directorate of School Education has stated that the government has decided that the Commissioners concerned shall assess the prevailing situation as per the Graded Response Action Plan (GRAP) and in view of the severe AQI levels in Delhi and surrounding regions....they may discontinue physical classes and issue necessary directions for holding online classes for up to Class 5 in the schools (government and private) in the interest of the health and safety of the students. The assessment for rural and urban areas of the districts concerned may be carried out separately. On Saturday, the air quality in eight cities -- Jind, Bahadurgarh, Bhiwani, Gurugram, Kaithal, Panipat, Rohtak and Sonepat - was "very poor" while in poor side, as per the air quality index (AQI), which is the average of past 24 hours. With the average particulate matter 2.5 at 394, Jind was the second most polluted city in the country after Del-

As per the evening bulletin of the Central Pollution



Control Board, Jind registered an AQI of 394, Bahadurgarh 388, Panipat 350, Rohtak 339, Bhiwani 325, Sonepat 325, Gurugram 320 and Kaithal 318 to remain among the cities with "very poor' air quality. Ballabgarh (288), Manesar (276), Dharuhera (276), Karnal (276), Kurukshetra (263), Yamunanagar (256), Faridabad (255), Charkhi Dadri (253), Palwal (249), Ambala (238) and Mandikhera (215) were among the cities where the air quality was on the poor

Victims can't drive criminal justice system through piecemeal settlements: HC

Chandigarh: The Punjab and Haryana High Court has made it clear that all disputes between parties are required to be resolved collectively for a settlement in criminal cases. The Bench made it clear that piecemeal settlements in criminal cases were inconsistent with established principles of law, particularly Section 482 of the CrPC and its corresponding provision in the

The question for adjudication before the Bench was whether partial quashing of criminal proceedings on the basis of partial compromise was permissible. The issue was raised after some HC Benches allowed the same, while others declined the relief. "In some situations the victim may attempt to be the driver of the criminal justice system. But to ensure that the victim or complainant, does not become the driver of the criminal justice system through making of piecemeal settlements, the courts are required to be not accepting any piecemeal settlements, rather are required to be rejecting piecemeal settlements..." the Bench asserted.

Taking up a bunch of 34 petitions against the States of Punjab and Haryana, the Bench asserted that the court's power to quash criminal proceedings, based on a compromise, was limited to instances where a full and a joint compromise was reached among all relevant parties. The Bench, for reaching the conclusion, drew heavily on precedents from the Supreme Court, including verdicts in the case of "Gian Singh versus the State of Punjab" and "Narinder Singh versus State of Punjab". The judgments established that the high courts had discretionary power to quash proceedings, even in non-compoundable cases, to prevent misuse of ju-



dicial processes provided that goodwill between parties was maintained. In the 27-page judgment, the court added that a piecemeal compromise undermined the prosecution's strength and impeded a fair trial. It held that any compromise omitting certain parties or defendants was in contravention of Section 246 of the BNSS, which mandated joint trials for all co-accused implicated in a single FIR. Accepting partial compromises could risk impairing the prosecution and the complainant's ability to uphold the charges effectively, potentially leading to inconsistencies and partial justice. Elaborating, the Bench observed partial compromises contradicted procedural mandates for joint trials which required accused named in a joint FIR to face a unified trial. The Bench also made it clear that its plenary jurisdiction under Section 482 of the CrPC was meant to prevent abuse of judicial

fenses, including those under the Prevention of Corruption Act, UAPA, POCSO, and cases involving serious charges such as rape, remained outside the compositional authority, irrespective of any settlement. The Bench added that offenses involving grievous harm or at tempted murder necessitated careful consideration of factors such as the assault's location on the victim's body, weapon type, and the authenticity of the compromise to ensure that settlements were not tainted by coercion or extrinsic inducements The court observed that Single Benches acted beyond established legal boundaries by accepting piecemeal settlements in certain cases and they should refrain from adopting such practices while ensuring alignment with binding legal precedents and statutory require-

Yamunanagar : As many as 32 FIRs have so far been registered against farmers for allegedly burning paddy residue in their fields in Yamunanagar district in the current harvesting season.Dr Satish Kumar Arora, Assistant Plant Protection Officer (APPO), Yamuanagar, said a fine was also imposed on the farmers against whom FIRs were registered. He further said a fine of Rs 35,000 was deposited by farmers in 14 of the total 32 cased."There was a provision to impose a fine of Rs 2,500 against each case of stubble burning. However, the Government of India has now issued a notification regarding the increased environmental compensation charges, which are double the previous charges," said APPO Dr Arora. He said the department had also made red entries in 61 khasra numbers of agricultural land of 32 farmers on the Meri Fasal Mera Byora (MFMB) portal stopping them from selling their crops in grain markets

of the state for allegedly



burning stubble.

Dr Aditya Pratap Dabas, Deputy Director, Agriculture, Yamunanagar, said they had taken the task of stopping farmers from burning the paddy residue. He said after getting information of active fire locations, the

committee formed by Deputy Commissioner Captain Manoj Kumar inspected the sites immediately and took action if stubble burning was found on the spot. Stubble burning is a crime as it causes harm to the environment as well as to the fertility of the


