

# Advantage BJP+ In Maharashtra, Close **Fight In Jharkhand, Predict Exit Polls**

Exit poll by Poll Diary gives NDA 122-186 seats, MVA 69-121 and others 12-29 in Maharashtra As per exit poll by People's Plus NDA will get 175-195 seats and INDIA will get 85-112 and Others 7-12. As per exit poll by Matrize NDA will get 150-170 seats and INDIA Bloc will get 110-130 seats.

New Delhi : Maharashtra the state where complication was a given in the assembly election -has left pollsters befuddled, with three out of seven predicting a hung house and the rest leaning towards the ruling alliance. Jharkhand, where most expected a clear outcome, did not offer much clarity, with poll analysts being divided sharply down the middle. Three are of the opinion that the ruling alliance will retain the state, three others appear equally convinced that the NDA will wrest it from the INDIA bloc

The aggregate of seven exit polls, though, indicates an NDA victory in Maharashtra. Data also indicates a close fight in Jharkhand, where the end result could be a split verdict.

The aggregate indicates that the Mahayuti -- ruling alliance of Eknath Shinde's Shiv Sena, Ajit Pawar's Nationalist Congress Party and the BJP could win 153 seats and the Maha Vikas Aghadi, the coalition of Uddhav Thackeray's faction of Shiv Sena, NCP Sharadchandra Pawar and the Congress,

#### IHC grants bail to Imran Khan in Toshakhana 2.0 case

**Islamabad :** The Islamabad High Court (IHC) on Wednesday granted bail to former Pakistan Prime Minister Imran Khan in the Toshakhana 2.0 case. IHC's Justice Miangul Hassan Aurangzeb approved PTI founder's bail plea, ordering the latter to submit surety bonds of Rs 1 million each for securing the bail, The Express Tribune reported. The court also directed the incarcerated former premier to appear before trial court following the bail. During the proceedings today, PTI's legal

counsel, Barrister Salman Safdar, argued that the charges against the PTI founder were based on the use of influence for personal gain. He contended that the chargesheet did not clearly specify who the main accused and the case was filed more than three years after the alleged incident. Barrister Salman further claimed that no crime had been committed under the Toshakhana policy, as the gifts were acquired in accordance with the established procedure, according to media reports.

Ranchi: Over 67 percent of the total 1.23 crore electors exercised their franchise amid heavy security arrangements for 38 seats in the second and final phase of the Jharkhand Assembly election on Wednesday.

According to the Election Commission data, the voter turnout was approximately 67.59 percent when polling officially drew to a close at 5 p.m. Of the total 81 constituencies in the state, 43 had voted in round one on November 13

According to the EC, the polling figure was the highest at 76.15 percent in Jamtara district, followed by Pakur at 75.88 percent. Bokaro district saw the lowest polling of 60.97 per cent. Among the Assembly constituencies, Maheshpur has recorded the highest turnout of 79.4 percent. The polling was lowest in the Bokaro constituency at 50.52 percent. The polling began at 7 a.m with people coming out to vote in large numbers wearing colourful

The National Democratic Alliance (NDA), helmed by the Bharatiya Janata Party is locked in an intense fight with the incumbent Jharkhand Mukti Morchaheaded Indian National Developmental Inclusive Alliance (I.N.D.I.A) for forming the next government in the tribal-dominated state.

Chennai : The Indian Space Research Organisation (ISRO) is preparing for the launch of European Space Agency's Proba-3 Satellite using its reliable workhorse launch vehicle PSLV from the SHAR. Range, Sriharikota on November 29.

The PSLV-C59 is expected to lift off from the First Launch Pad at the Satish Dhawan Space Cen-

The preparations for the launch are going underway at Sriharikota, report said

Proba-3 is a dual probe technological demonstration mission by the European Space Agency (ESA) devoted to high precision formation flying to achieve scientific coronagraphy.

It is part of the series of PROBA satellites that are being used to validate new spacecraft technologies and concepts while also carrying scientific instruments.

Proba-3's innovative approach involves two satellites flying in precise formation, with one casting a shadow on the other to



block out the Sun's disk and the ISRO was expected to use it PSLV XL version for the launch.

The Proba-3 mission is collaboration between the ESA and ISRO. The mission's goals are

to use two satellites to study the Sun's corona, the outermost part of its atmo-

sphere.The two payloads are Coronagraph spacecraft 340 kg and Occulter spacecraft 200 kg.

The satellites will fly in formation to create a solar coronagraph that will al-

low for uninterrupted observation of the Sun's corona

The Proba-3 mission

The Proba-3 satellites will reach a high elliptical orbit that is 60,000 kms from Earth. The satellites will fly autonomously to maintain a precise position, with an accuracy of a single millimeter.

In its website, ESA said Proba-3 is ESA's - and the world's - first precision formation flying mission A pair of satellites will fly together maintaining fixed configuration as 'large rigid structure' in space to prove formation flying technologies and rendezvous experiments.

The mission will demonstrate formation flying in the context of a large-scale science experiment.

The two satellites will together form an approximately 150-m long solar coronagraph to study the Sun's faint corona closer to the solar rim than has ever before been achieved.

Beside its scientific in terest, the experiment will be a perfect instrument to measure the achievement of the precise positioning of the two spacecraft. It will be enabled using a wide variety of new technologies.

### 12 security personnel killed in suicide attack on joint check post in Bannu: ISPR

Bannu (Pakistan) : At least twelve security personnel were killed in a suicide attack on a joint check post in Bannu district of Khyber Pakhtunkhwa province, an official said. The attack on a joint check post in Bannu district resulted in the killing of 12 Pakistani soldiers, including 10 from the security forces and two from the Frontier Constabulary, Express Tribune reported quoting (ISPR). The

attack was carried by Khwarij, who attempted to breach the check post in the general area of MaliKhel, the ISPR said in a statement.During the ensuing exchange of fire, six terrorists were killed, it said. However, in an attempt to break through the post's defences, the terrorists rammed an explosive-laden vehicle into the perimeter wall, triggering a suicide blast, according to media reports.

# **Delhi air quality improves** slightly, back into 'severe' category

New Delhi: A42-year-old woman and her daughter were killed in a fire that broke out in a slum in south Delhi's Neb Sarai on Tuesday. The deceased were identified as Farzana and her daughter Ravina. The fire department received a call around 2.12 am on Tuesday and 14 fire engines with 84 firefighters were dispatched to the scene, along with police. A fire official said that after a five-hour battle, the fire was brought under control. Two badly burnt bodies were found in a single hut. The victims were identified as the mother and daughter.According to the fire department, about 100 huts were built on about 4,000 square yards. The fire spread rapidly, engulfing one hut af-ter another. Panic ensued. Initially, people tried to extinguish the fire themselves, but it quickly spread beyond control. "Due to the presence of combustible materials, the fire spread quickly, giving no chance for the mother and daughter to escape,' the officer said. Police are investigating the cause behind the fire. According to Delhi Fire Service (DFS), the materials used for the construction of JJ clusters are highly combustible and produce toxic gases. This makes these structures extremely vulnerable to fire hazards, leading to rapid fire spread and posing significant risks to the lives of residents. The use of substandard materials, lack of fire safety measures, and overcrowding in these clusters exacerbate the fire risk.In another incident, a fire broke out in a JJ Colony, prompting the deployment of 16 fire tenders. Over 150 shanties were gutted. Another fire engulfed a factory in the area, and 22 fire tenders were sent. No one was in-

New Delhi : Delhi's air quality showed a slight improvement on Wednesday morning, shifting from the "severe plus" category to "severe." However, the city remains shrouded in a thick smog that continues to affect visibility and overall air quality.At 9 a.m., the Central Pollution Control Board (CPCB) recorded an air quality index (AQI) of 424, which falls under the "se-

Train operations also faced disruptions, with the railways reporting delays for 13 trains and the rescheduling of nine others due to the dense smog.

The ongoing pollution crisis has also impacted the Yamuna River, where toxic

foam was observed floating near Kalindi Kunj and Okhla Barrage. According to SA-FAR-India, AQI levels in different parts of Delhi ranged from 382 to 465, reflecting alarming levels of pollution.

To address the worsening situation, Delhi Police are enforcing Stage IV of the Graded Response Action Plan (GRAP), which includes restrictions on older diesel vehicles. Meanwhile,

## This winter you may not have to wait endlessly onboard planes to take off at foggy Delhi Airport

New Delhi : This winter, passengers at Delhi Airport may experience significant relief from prolonged waits inside aircraft during lowvisibility conditions. The Bureau of Civil Aviation Security (BCAS) has introduced a new policy allowing passengers stranded due to weather or technical delays to disembark and re-enter smoothly without undergoing repeated security checks. ### At AIIMS Delhi, patients stare at 3-year waitlist for MRI scan

New Delhi : Unless you are a VIP, getting an MRI scan done at the city's premier hospital, the All India Institute of Medical Sciences (AIIMS), could stretch from a mere few weeks to an ago-

nising three years. Recently, a 52-year-old Joydip Dey, who was referred to AIIMS for treatment for his right leg injury at the orthopaedic OPD, was given an appointment for an MRI (magnetic resonance imaging) scan on Sept 7, 2027.

Insiders acknowledge that this extended waiting period is not unique, as numerous other patients encounter similar delays in their appointments for MRI scan and other imaging procedures.

Each day, about 15,000 patients visit the outpatient department at AIIMS. Of these, roughly 10% require diagnostic imaging procedures, such as ultrasound, Xray and MRI scans. The waitperiod for these ing procedures varies significantly, with numerous patients receiving appointment dates ranging from six months to three years ahead. Dey said being a BPL

(below poverty line) patient, it is impossible for him to seek treatment at a good pri-

vate hospital in Delhi-NCR, where an MRI scan can cost anything between Rs 18,000 and Rs 25,000.

"I don't have that kind of money. I can't even pay Rs 4 000-5 000." he said, adding that during his last visit to AIIMS Delhi on Nov 9 this year, the OPD doctor, after finding out that MRI scan was scheduled after three years, insisted that he must get it done immediately even if it is in a private hospital. "I don't know what to do. I have exhausted all my options. So, I stopped the treatment," he

told.AIIMS offers MRI diagnostic services at affordable and economical rates, typically ranging between Rs 2,000 and Rs 3,000.In 2022, Dr M Srinivas, the institute's director, issued instructions to ensure round-the-clock operation of all MRI machines. This directive aimed to facilitate scans for both

inpatients and outpatients within the hospital premises, preventing treatment delays caused by extended MRI waiting times. He also emphasised that "the number of appointments for MRI will be increased to reduce the waiting list".Prof Rima

The Taj Mahal could be central to India's 2036 Olympic bid

New Delhi : Neither Mumbai nor Ahmedabad but the Delhi National Capital Region (NCR) and Agra — home to the Taj Mahal — could be the leading choice for India to host the 2036 Summer Olympics, should the International Olympic Committee (IOC) give them a goahead.

After India's expression of interest to host the 2036 Olympic and Paralympic Games, the next major step in the process will be identifying the potential host city. So far, Ahmedabad and Mumbai were being seen as the leadchoices.Ahmedabad ing was being seen as frontrunner by virtue of being home to the 1.32 lac capacity Narendra Modi cricket stadium while Mumbai, India's financial capital, was being touted to be the other obvious choice given the commercial behemoth that an event like the Olympics can go on to be

However, contrary to reports, the Delhi-NCR and Agra region could turn out to be the front runners in the near future for the following reasons: 1) Delhi is the

country's national capital and the gateway to some of India's prime tourist destinations, 2) Connectivity in and around Delhi-NCR and Agra has been growing at a rapid pace and there are already four airports that can serve the heavy flow of visitors, 3) There is a major source of land available for new construction, going forward, 4) The Taj Mahal, a wonder of the world, could provide the theme and setting for India to promote the idea of being worthy hosts.As has been evident over the years, consideration for the Olympic bid will not hinge just on the regions and favouritism but on multiple factors such as tourism potential, manufacturing industry, space, accessibility, airports and population size.

Keeping that in mind, with tourism as the central aspect, no spot is more iconic for India than the Taj Mahal. Additionally, previous successful bids have banked on prominent sites to showcase their candidature. For London 2012, river Thames and Tower Bridge were central, at Rio the Olympic bid.

Mahendragarh records 15% rise in road accidents in10 months

Mahendragarh : Contrary to the target of reducing road mishaps this year, Mahendragarh district has recorded a rise of 15 per cent in roadside accidents in the past 10 months (from January to October) of current year as compared to the corresponding period last year

As per sources, a total of 278 road mishaps have been reported in the district from January to October this year, which claimed lives of 128 people and left 394 others injured while a total of 242 road accidents were registered in the corresponding period of 2023 with the death of 122 people and injuries to 208 persons. "Over speeding, illegal cuts and lack of sign boards on highways, least strictness in issuing challans against violators of traffic rules are the main reasons behind the road mishaps in Mahendragarh district. The rise in the number of road accidents is indeed a matter of concern," said Rajesh Kumar, an office-bearer of Road Safety Organisation (RSO). He said over 15 black spots had been identified in the district, which were prone to road mishaps due to multiple reasons. "The situation gets more risky for driving especially in winter when dense fog



reduces the visibility. However, awareness campaigns are being run in educational institutes and other places to motivate the students to follow traffic rules in order to put a check on the road mishaps," he added. Rajesh claimed that many persons did not bother to wear helmet while riding two wheelers and to use seat belt while driving four-wheelers. "Such violators should be dealt with strictly by issuing challans against them so that they do not forget to

follow traffic rules in future," he added.

As far as traffic challans are concerned, the district police authorities had issued a total of 702 challans in August. Among them, the highest 144 challans were issued for not wearing helmet, 72 for overspeeding, 19 for driving without seat belt, six for using mobile phone while driving, three for wrong side driving, two for drunken driving and 456 for other violations of the traffic rules, said the sourc-

Meanwhile, Deputy es. Commissioner Vivek Bharti said all efforts were being made to bring the count of accidents down in the dis-

trict. "The officials concerned have been directed to close all illegal cuts on the highway and draw white lines on all roads in view of foggy season. The National Highways Authority of India and PWD (B&R) officials have also been asked to get the safety audit of their roads done," he added.

## **Chandigarh: Doctors differ on drawing** parallel between poor AQI, smoking

Chandigarh : The Air Quality Index (AQI) of the City Beautiful, which touched 425 last Thursday, worst ever for the city and higher than New Delhi (423), moderated to "poor" (203) today. Fresh memes on AQI have flooded the social media with one of them suggesting "smoking in Bangalore is healthier than doing yoga in Delhi'.Prof Ashutosh N Aggarwal, Head, Department of Pulmonary Medicine, PGI, said, "There is no simple formula to draw an equivalence between air quality and smoking tobacco. However, full day exposure to an AQI greater than 400 (categorised as 'severe') with PM2.5 (particulate matter) concentrations of >250 µg/m3 might roughly have the same health hazards as smoking >10 cigarettes that whole day." Dr Ravindra Khaiwal, Professor of Environmental Health, Department of Community Medicine and School of Public Health, PGI, termed equating AQI with smoking tobacco as misleading. He said, "Many online platforms and media outlets compare AQI to cigarette smoking. However, this comparison should be based on PM2.5 levels, not AQI. A PM2.5 concentration of 22.5  $\mu$ g/m<sup>3</sup> is roughly

equivalent to smoking one cigarette. That said, it is incorrect to compare air pollutants with cigarette smoking because it can create a false perception that smoking is less harmful Smoking a single cigarette exposes a person to over 70 known harmful chemicals/carcinogens at once. While raising awareness about the dangers of high levels of air pollution, using AQI and PM2.5 calculators is important, equating it with smoking risks normalising tobacco use can be counterproductive."Not all doctors hold the same opinion. Contrary to the PGI doctors, Dr Robin Gupta, consultant pulmonology, Paras Health, Panchkula, confirmed that exposure to "poor" air quality is akin to smoking cigarettes, posing significant risks to lung health. He said, "The AQI levels above 100 can cause irreversible damage AQI between 101 and 200 is comparable to smoking 4-10 cigarettes per day. It goes up to 10-20 cigarettes per day for 201-300 level and around 20 cigarettes per day for 300 level.' Common harmful pollutants in AQI >100 are particulate matter (PM), nitrogen dioxide (NO2), ozone (O3) and carbon monoxide (CO)



# Khattar bats for providing 50% help before marriage under vivah shagun yojana

Karnal : Union Minister of Power and Housing and Urban Affairs Manohar Lal Khattar, suggested providing at least 50 per cent of the eligible amount to beneficiaries under the Mukhya Mantri Vivah Shagun Yojana on the day of the wedding itself. "It came to my notice that benefits are given several days after the registration of marriage. I have suggested the officials provide 50 per cent of the amount on the wedding day and the rest of the amount should be given after the marriage. I will suggest the same to the state government to implement it," said Khattar, while reviewing the District Development Coordination and Monitoring Committee (DDCMC-DISHA) at the Mini-Secretariat on Tuesday. Yamunanagar : The Regional Transport Authority (RTA), Yamunanagar, has started a special drive to reduce road accidents during the foggy season.

On the directions of DC Capt Manoj Kumar, officials of the RTA are making drivers aware about careful driving, putting reflector tapes on vehicles and issuing instructions to drivers to drive under-loaded vehicles. Inspector of RTA, Yamunanagar, Vikas Yadav said that vehicles were not visible in the absence of reflector tapes in the foggy season causing a number of road accidents.

"The Regional Transport Authority, Yamunanagar, has started a special drive to avert road accidents during the foggy season. Two teams of the RTA have started putting reflector tapes on the vehicles," said Inspector Vikas Yadav. He said the stray cattle roaming on the roads were also being made to wear reflector belts so that the possibility of accidents was minimized by stray cattle on the roads. 

# Farmers protest canal remodelling in Sirsa

Sirsa : The canal remodelling work undertaken by the Irrigation Department has sparked protests by farmers in several villages. The Ban Mandori distributary, supplying water to villages like Shahpur Begu, Arnianwali, Dhingtania, and Rangri Khera, has been revamped. However, locals claim the changes have disrupted water supply to around 10,000 acres of farmland.

For the past five days, dozens of farmers from these villages have been protesting near the canal. Farmer Ashok Kumar alleged that the department lowered the canal bed across about four km near Nezia village on November 14, leaving the middle section dry while water reached the tail end. He explained that the elevation of fields near the canal now exceeds the canal level preventing water from flowing into these areas.

Sharing his views, farmer Harbans said the groundwater in the area was 200-250 feet deep and was saline, making it unsuitable for farming. The fields depend entirely on canal water. He added, "If we use pipes to

Another farmer Prithvi Singh accused the departmentof political interference, claiming the canal bed was intentionally lowered by 1.5 to 2 feet in some areas. He cited a similar issue in Bakrianwali village, where residents of five villages had been protesting for months.

## **Coetzee, Edwards & Sufyan reprimanded** for breaching ICC Code of Conduct

Dubai : Netherlands captain, Scott Edwards, Oman bowler, Sufyan Mehmood and South Africa bowler, Gerald Coetzee have been found guilty of breaching the ICC Code of Conduct in their matches over the weekend.

Edwards was found to have breached two articles of the ICC Code of Conduct for Players and Player Support Personnel. Article 2.8 which relates to "showing dissent at an umpires decision during an international match" and also article 2.2 which relates to "abuse of cricket equipment or clothing, ground equipment or fixtures and fittings during an International Match."

Both breaches followed his dismissal during the third T20I between Oman and the Netherlands. The first incident occurred when Edwards showed his bat to the umpire when given out LBW

The second incident was when he threw his bat and gloves onto the field when returning towards his team's dressing room.

The cumulative sanctions see that the captain has been fined 10% of his match fee and received two demerit points - one point for each offence which have been added to his disciplinary record.

In the same match, Mehmood was fined 10% of his match fee and had one demerit point added to his disciplinary record after being found to have breached Article 2.5 of the ICC Code of Conduct for Players and Player Support Personnel, which relates to "using language, actions or gestures which disparage or which could provoke an aggressive reaction from a batter upon his/her dismissal during an International Match.'

The incident took place when the bowler (Mehmood) dismissed the batter, Teja Nidamanuru, giving him a send-off by pointing him back towards his team's dressing room.

Both Edwards and Mehmood admitted their respective offences and accepted the sanctions proposed by Neeyamur Rashid Rahul of the ICC International Panel of Match Referees and, as such, there was no need for a formal hearing. On-field umpires Harikrishna Pil-



lai, Rahul Asher and third umpire Vinod Babu levelled the charges.

In the fourth T20I between South Africa and India, Gerald Coetzee was was found to have breached Article 2.8 of the ICC Code of Conduct for Players and Player Support Personnel, which relates to "showing dissent at an umpires decision during an international match". The incident occurred when Coetzee made an inappropriate comment to the umpire after a 'wide' was called following one of his deliveries. Coetzee received a reprimand and

had one demerit point added to his disciplinary record. He admitted the offence and accepted the sanction proposed by Andy Pycroft of the Emirates ICC Elite Panel of Match Referees, therefore no formal hearing was needed.On-field umpires Allahudien Paleker and Stephen Harris, third umpire Lubabalo Gcuma and fourth umpire Arno Jacobs levelled the charge.Level 1 breaches carry a minimum penalty of an official reprimand, a maximum penalty of 50 per cent of a player's match fee, and one or two demerit points.

## ICRA projects GDP growth to slow down to 6.5 pc in Q2, full-year growth seen at 7 pc

New Delhi : Research and rating firm ICRA on Wednesday projected India's GDP growth to slow down to 6.5% in July-September quarter (Q2) of current financial year 2024-25 (FY25) due to factors like heavy rains and weak corporate margins.

Ministry of Statistics & Programme Implementation (MoSPI) will release the GDP estimates for the September quarter on November 29, 2024.

In its estimate, ICRA said that while government spending and kharif sowing have shown positive trends, the industrial sector, particularly mining and electricity, is expected to slow down. It further said that despite these challenges the services sector is projected to improve, and a back-ended recovery is anticipated, leading to a full-year GDP growth of 7%."However, risks such as a slowdown in personal loan growth and geopolitical uncertainties remain," it said.As per ICRA, the growth in the gross value added (GVA) is estimated to ease to 6.6% in Q2FY25 from 6.8% in Q1FY25, driven by the industrial sector, amid a pick-up in the



expansion in services and agricultural

"Based on available data for the Centre and the states' indirect taxes and subsidies, ICRA estimates that the growth in net indirect taxes (in nominal terms) rose slightly to 9.0-9.5% in Q2 FY2025 from 8.0% in Q1 FY2025. Given this, the GDP-GVA growth wedge (in real terms) is expected to remain inverted in Q2 FY2025 as well," it said

Aditi Nayar, Chief Economist, Head-Research & Outreach, ICRA said that Q2 FY2025 saw tailwinds in terms of a pick-up in capex after the Parliamentary elections as well as healthy expansion in sowing of major kharif crops.

"Several sectors faced headwinds on account of heavy rainfall, which affected mining activity, electricity demand and retail footfalls, and a contraction in merchandise exports. Further margins appear to have weakened for corporates in a variety of sectors in this quarter. As a result, we project a slight dip in India's GVA and GDP growth in O2 FY2025 to 6.6% and 6.5%, respectively," she said.

# India eyeing 10 pc of global space economy in next two decades: ISRO chief

Bengaluru : India is set to expand its share of the global space economy from less than 2% to at least 10% over the next two decades, with a focus on harnessing the full potential of the entire space value chain, ISRO Chairman S Somanath said on Wednesday.

Addressing the Bengaluru Tech Summit 2024, Somanath said the ambitious goal spans across three key segments: upstream (satellite manufacturing and launches), midstream (infrastructure and applications), and downstream (data-driven solutions) The ISRO Chairman underscored the critical role of India's talented workforce in unlocking the potential of these segments. "Downstream activities, in particular, hold immense promise. By investing in skill development, we can catalyse advancements across all facets of space technology," he stated. The Space Policy 2023 and ongoing reforms were highlighted as pivotal to this transformation. The policy clearly defines the roles of the Indian Space Research Organisation (ISRO), the NewSpace India Limited (NSIL), and private entities in driving innovation and growth. Additionally, the FDI (Foreign Direct Investment) framework is expected to attract global investments, further positioning India as a leader in the space industry. The Chairman also pointed to the government's Space Mission 2047 as a visionary initiative aimed at advancing space exploration in India. Somanath emphasised the significance of international collaborations in India's space strategy, citing high-profile projects like the NISAR satellite with NASA, the LUPEX mission with Japan, and various climate monitoring initiatives under the leadership of the G20.

This is in keeping with Bhutan's vision for its energy sector which is to take its overall generation capacity to 25,000 MW by 2040 for its energy security and regional energy integration, according to a media statement here on Wednesday.

Bhutan's hydropower generation which peaks during the monsoon months complements India's demand patterns that also peak in the summer months. More importantly, Bhutan sees its hydropower as critical in ensuring round-the-clock availability of power with India's huge investments in renewables such as solar and wind and the plans to further accelerate investments in these renewables over the next two decades. With the recent agreement reached for Bangladesh to import power from Nepal through India, there are also growing opportunities for regional energy integration that would boost investments in Bhutan's hydropower.

These partnerships, he stated, are essential in advancing India's position in the global space ecosystem.

India's recent achievements were also highlighted, particularly the historic landing of Chandrayaan-3 on the Moon and the successful launch of the Aditya-L1 solar observatory. The ISRO Chairman announced ambitious future milestones, including human spaceflights by 2026, the establishment of an Indian space station by 2028, and plans for a lunar human landing by 2040. These developments align with ISRO's broader roadmap to cement India's place as a key player in space exploration.

Reflecting on previous setbacks, such as the Chandrayaan-2 mission, the Chairman remarked: "Every setback provided invaluable lessons. Chandrayaan-3, developed entirely in-house, stands as a testament to India's resilience and ingenuity.

The collaboration between ISRO and over 400 private-sector companies was recognised as a critical factor in fostering the growth of India's space ecosystem. The Chairman highlighted the importance of privatisation initiatives, such as the PSLV (Polar Satellite Launch Vehicle) and SSLV (Small Satellite Launch Vehicle) programmes, in driving innovation and enhancing the commercial viability of space startups.

"Our work involves close collaboration with governments, ministries, departments, and user segments. Traditionally, our primary users have been government bodies, shaping demand aggregation across sectors like agriculture, climate, natural resources, and cartography.

This demand guides us in designing sensors, launching satellites, and delivering critical data services," he explained.

Despite the ongoing transition of space-based communication in frastructure management to NSIL. the Chairman acknowledged that the penetration of space applications into daily life remains limited. This, he noted, represents an untapped opportunity for economic growth.

Despite operating with a relatively modest budget, India's space programme has consistently delivered world-class results. The Chairman affirmed that continued investment in research and development (R&D) and capacity-building initiatives will drive the next wave of growth, ensuring that India remains at the forefront of the global space economy.

'With focused efforts and collaborative frameworks, India's space sector is poised for unprecedented growth," he concluded.
