

JPC report on Waqf bill: Chairman has power to remove note that casts aspersion on panel: Rijiju

New Delhi: Parliamentary and Minority Affairs Minister Kiren Rijiju on Thursday slammed the Opposition for calling the Joint Parliamentary Committee (JPC) report on the Waqf Amendment Bill as "illegal and unconstitutional" and said that Chairman Jagdambika Pal has the authority to remove a note "that casts aspersion on the Committee"

Addressing the media at the Parliament House here, Rijiju defended the Chairman of the panel and said, "It should be clear that Pal has the authority to remove a note that casts aspersion on the Committee.

The JPC Chairman has the power to delete a portion. It is also mentioned in the rule, and everything

happened as per rule."

Objecting to the Opposition members calling the "JPC report as illegal and unconstitutional", he said, ". The JPC was formed by all the parties and it is not of one party. This is not just an NDA report. This is Parliament's Joint Parliamentary Committee so calling the JPC report as illegal and unconstitutional is not correct"

Rijiju said that the JPC report has an importance and if the Opposition were speaking against this report then they were "dismissing their own report"

As far as the report is concerned there can be differences in the opinion within the JPC, the Minister added

"There are basically two

opinions - one is those who are in the government, they might have separate opinion than those in the opposition. Even the opposition's views have been put in the annexure. It is wrong to say that the opposition's dissent notes are not included in the

Every view whether those considered by the majority or rejected by the majority have been included in the JPC report which was tabled in the RS today and which would be tabled in Lok Sabha," he said.

Rijiju said that the JPC report has been tabled on the floor of the House, now it will come to the government and then the report will be considered by the Cabinet. And after the consideration of the Cabinet then

whatever the amended version will be, it will then be presented in the Parliament.

The Minister said that the Opposition was already opposing the Bill which is not good and appealed to all the opposition parties to let the house consider this report as the "JPC has done a great length of consideration, hearing, debate and discussion.

China urges U.S. to drop zero-sum mentality

Los Angeles: A U.S. military aircraft crashed into the San Diego Bay on Wednesday, according to the San Diego Fire-Rescue.

The order said failure to implement the president's agendaisagainstprofessional discipline and may lead to the termination of personnel.

The order came as Trump instituted changes to ensure U.S. foreign policy is aligned with his "America First" agenda.

The executive order said U.S. Secretary of State Marco will implement Rubio

reforms in recruiting, performance, evaluation and retention standards to "ensure a workforce that is committed to faithful implementation of the President's foreign policy." "The Secretary must

maintain an exceptional workforce of patriots to implement this policy effectively," the order said. "The Secretary shall, consistent with applicable

law, reform the Foreign Service and the administration of foreign relations to ensure faithful and effective implementation of the President's foreign

policy agenda," it added.

Ukraine-Russia conflict must end, Hegseth, rules out NATO membership

Washington: US Secretary of Defence Pete Hegseth on Wednesday said Ukraine-Russia that the conflict must end, Kyiv's NATO membership is unrealistic, and the US will no longer prioritise European and Ukrainian security as the Trump administration focuses on securing its borders and deterring war with China, media reports said on Thursday.

In remarks before a meeting of the Ukraine Contact Group, Defence Hegseth also said that European troops should be the primary force securing a postwar Ukraine-something US troops will not be involved in, the CCN reported on Thursday. "The United States does

believe that NATO not membership for Ukraine is a realistic outcome of a settlement," negotiated Hegseth said. And he added that any security guarantees offered to Ukraine "must be backed by capable European and non-European troops,' according to CNN report.

"To be clear, as part of any security guarantee, there will not be US troops deployed to



Ukraine," he said.

Hegseth also said that a return to Ukraine's pre-2014 borders, before Russia invaded Crimea and eastern Ukraine, "is an unrealistic objective."

According to reports, NATO allies, including Hegseth, agree that regaining Crimea from Russia is not realistic, and even Ukrainian Volodymyr President Zelensky has not emphasised this as a prerequisite for peace talks. One NATO official said it would have been more concerning if Hegseth had said that returning to Ukraine's pre-2022 borders was unrealistic.

But the comments about security guarantees are sure to concern Zelensky, who said this week that Europe alone cannot provide meaningful security guarantees to Ukraine without American leadership. Zelensky has also

continued to insist that his country joining NATO is the only way to deter Russia from launching new attacks in the future. According to reports,

President Trump announced his conversation with Russian President Vladimir Putin on Wednesday morning, hours after Hegseth's speech. Trump said the two agreed

work "very closely" to together begin and negotiations "immediately" on ending the war in Ukraine.

"We will begin by calling President Zelensky, of Ukraine, to inform him of the conversation," Trump added.

Kremlin The on Wednesday said that Putin invited Trump to visit Moscow, which would mark the first visit by a US president since 2013, the report said.

Zelensky shortly after getting off the phone with Putin.

Later on Wednesday afternoon, Trump said he agrees with Hegseth and does not "think it's practical" to have Ukraine join NATO, the report said.

"I don't think it's practical to have it. Personally, I know that our new secretary of defence is excellent. Pete made a statement today saying that he thinks it's unlikely or impractical. I think probably that's true. I think long before President Putin, they said there's no way they'd allow that. This has been going on for many, many years. They've been saying for a long time that Ukraine did not go into NATO, and I'm okay with that,' Trump said from the Oval Office.

A European defence official told CNN that while many in NATO don't necessarily believe Ukraine can join the alliance given the political realities with Russia, they also don't say so publicly-as Hegseth didbecause they want to avoid giving Russia the idea that it can dictate who can and cannot join.

Afghanistan: Death toll from terrorist attack in Kunduz rises to 8

Kabul: The death toll from a terrorist attack carried out by a suicide bomber in the Afghan city of Kunduz has risen to eight, a spokesperson for the Afghan Interior Ministry said. "Unfortunately, yesterday we witnessed a heartbreaking incident in Kunduz, as a result of which eight people, including mujahideen and civilians, became martyrs, and some were injured," the spokesperson was quoted as saying by the Salam Watandar radio station on Wednesday. The

investigation into the incident is under the close supervision of security forces, and, according to the initial data, "the roots of this sinister crime lie outside the country," the spokesperson added. On Tuesday morning, a suicide bomber blew himself up outside a Kabul bank branch in Kunduz, where government employees had gathered to collect their salaries. The Islamic State terrorist group (IS or ISIS, banned in Russia) claimed responsibility for the attack.

arrested after 2 years in Agra New Delhi : A 32-year-old Delhi University graduate was arrested after two years for allegedly killing a milk supplier following a monetary dispute in West Delhi's Punjabi The accused, Bagh. Rajesh Kumar, a resident of Vishnu Garden, was apprehended from Vishu Vihar in Agra for his involvement in the incident that took place in April 2023. According to DCP (West) Vichitra Veer, the victim, Brijbir Singh, had been supplying milk for nearly two decades. He then handed the bat to Kapil, who hit Singh on the forehead, inflicting serious injuries. Delhi Police detain 14 students amid protest and Vandalism at Jamia Millia Islamia

New Delhi : Delhi Police have taken 14 individuals into custody in connection with a protest and incidents of vandalism at Jamia Millia Islamia University. According to the university administration, a group of students had gathered illegally in the academic block on the evening of February 10, causing disruptions and damage to university facilities.

University officials stated that over two days, the protesting students vandalized property, including damaging the central canteen and breaking the gate of the security advisor's office. The administration condemned these actions, citing concerns over defaced walls, disruption of academic activities, and the discovery of prohibited items in possession of some students.

This incident followed a larger demonstration earlier in the week, where a significant number of students protested against what they perceived as the administration's crackdown on student activism. The protest, led by Leftleaning student groups such as the All India Students Association (AISA) and the

All India Revolutionary Students Organisation (AIRSO), accused the university of suppressing dissent. The demonstration occurred just ahead of a key disciplinary committee meeting scheduled for February 25 to address the case of two PhD students accused of organizing last year's anti-Citizenship Amendment Act (CAA) protest.On Thursday morning, university officials, with assistance from the police, dispersed the students from the protest site to restore order on campus. A case was subsequently filed against 14 individuals iden-

tified by the university. In response to the situation, security at the campus gates was tightened, with paramilitary forces and anti-riot vehicles deployed outside. Entry to the university was restricted, with only students carrying valid identification being allowed inside.The crackdown on student protests at Jamia Millia Islamia is reminiscent of past incidents, notably the December 15, 2019, anti-CAA protests. During that event, police allegedly entered the university library and used force on students while searching for outsiders, sparking nation-

wide protests against the Citizenship Amendment Act (CAA) and the National Register of Citizens (NRC).

The recent events highlight the ongoing tensions between the university administration and student groups. While the administration emphasizes the importance of maintaining order and discipline, students claim their right to protest is being systematically undermined. With the disciplinary hearing on February 25 approaching, the issue of student activism at Jamia Millia Islamia remains a subject of intense debate and contention.

Work on Ghazipur mound of shame to resume soon

New Delhi : The Municipal Corporation of Delhi (MCD) is set to begin the second phase of biomining at the Ghazipur landfill by late March, following similar operations at the Bhalswa and Okhla landfills. Activities at Bhalswa and Okhla started in January after the Supreme Court authorized the municipal commissioner to implement six waste management programs.

A municipal official stated on Tuesday that the work order for biomining at Ghazipur will be issued by Friday, and operations are expected to begin within 12-15 days. "The delay occurred due to high quotes from bidders, which required re-tendering. The agency we finalized will charge Rs 395 per tonne instead of Rs 495 per tonne for processing the waste," the official said. The project at Ghazipur will cost around Rs 177 crore.

Currently, Bhalswa's contractor processes 8,000 tonnes of legacy waste daily, while Okhla handles 5,000 tonnes. MCD expects to process a minimum of 8,000 tonnes daily at Ghazipur, targeting a total of 30 lakh tonnes, with an additional 15 lakh tonnes potentially being



processed if the contract is executed on time. Ghazipur accounts for 45% of the 160 lakh tonnes of legacy waste across Delhi's three major landfills.

In the second phase, the contractor at Bhalswa is tasked with processing 30 lakh tonnes within 18 months at a rate of Rs 423 per tonne, with the project costing around Rs 190 crore. Meanwhile, at Okhla, the contractor will be paid Rs 404 per tonne to manage 20 lakh tonnes, with the potential to process an additional 10 lakh tonnes if completed on time, at a total cost of Rs 121 crore.

Lieutenant Governor VK Saxena recently visited Bhalswa and directed that the daily processing be increased to 12,000 tonnes. "MCD has reclaimed around 20 acres of land at Bhalswa

after processing 45 lakl tonnes during Phase I. The LG has instructed the development of a green space on at least 5-6 acres to beautify the area and demonstrate the res toration efforts," a civic official said.Sources indicate that the second phase of biomining at all three landfills will be closely monitored by the Prime Minister's Office, which will also oversee the Yamuna cleaning initiatives. The biomining efforts at Okhla, Bhalswa, and Ghazipur were launched in 2019 after the National Green Tribunal raised concerns about the public health risks caused by the massive garbage heaps. A patient has died in Mumbai due to the rare disease Gulen-Barre Syndrome (GBS), which has been spreading across the state. After Pune and Solapur, this disease has now shown its presence in Mumbai too. A resident of Wadala area, who was admitted to Nair Hospital in Mumbai, died of this disease. This patient was working as a ward boy at BN Desai Hospital of Mumbai Municipal Corporation.

According to the Health Department report, the number of GBS infected patients in the state has reached 197. Recently, five more new patients have been found in Pune division. These include 40 patients from Pune city, 92 from newly incorporated villages, 29 from Pimpri-Chinchwad and 28 from Pune rural. Currently, 50 are undergoing treatment in the ICU and 20 patients are on ventilators.

A 53-year-old patient undergoing treatment at Nair Hospital died on February 10. This patient did not have fever or diarrhea, but he fell ill 16 days after returning from a tour of Pune. A 16-year-old student from Palghar, who is suffering from GBS, is undergoing treatment at the same hospital and her condition is improving.

GBS is not a contagious disease, but an autoimmune disorder. The body's immune system attacks the nervous system, which weakens the muscles and can even cause paralysis in severe cases. It is not transmitted from one person to another, but it can develop after a viral or bacterial infection.

As the number of GBS patients is increasing rapidly, a question mark has been raised on the municipal corporation's water supply system. It is initially estimated that the prevalence of this disease has increased due to drinking contaminated water. The municipal corporation has failed to provide clean water to the citizens. Even today, water is supplied to Pune through 1,000 private tankers every day, on which citizens are spending lakhs of rupees. After the increase in the number of GBS patients, the water of wells in Dhayari, Nanded, Ambegaon areas was tested and it was revealed that it was contaminated. However, if the municipal corporation had taken proper measures for water purification in time, this spread could have been prevented.

Although Pune is a rapidly growing city, civic amenities are still inadequate. As a result, the empire of tanker mafia has flourished. The government and the Municipal Corporation should take immediate steps to improve water supply and health services.

The Municipal Corporation has appealed to people to contact the nearest Municipal Hospital without panic if they experience symptoms of GBS. If diagnosed and treated on time, the disease can be cured. However, the GBS epidemic has ruined the unplanned civic amenities of the municipality. The health of citizens has been put at risk due to inefficiency in the health system and contaminated water supply. If public institutions do not take timely measures, more serious consequences may be seen in the future. Even if it is not a contagious disease, careless infection is more dangerous!

All the municipal hospitals and medical colleges in Mumbai are equipped for GBS treatment. The municipal administration is clarifying that the necessary medicines, equipment and expert manpower are available for the treatment of patients. Citizens should not panic if they experience any symptoms of Guillain-Barré Syndrome (GBS). The municipal administration has also appealed to immediately contact the nearest municipal hospital for guidance and treatment.

Guillain-Barré Syndrome is a rare autoimmune disorder, in which the body's immune system attacks its own nervous system. This weakens the muscles and can even lead to paralysis in severe cases. Guillain-Barré Syndrome (GBS) is not a contagious disease. It does not spread from one person to another. The exact cause is unknown. This disease occurs after a respiratory or digestive tract infection. It needs to be treated immediately. Guillain-Barre Syndrome is not a new disease, it has been known for many years. Although it is not a contagious disease, sometimes it can develop after a bacterial or viral infection. There are also many other causes of GBS. Guillain-Barre Syndrome occurs throughout the year. Approximately one in 1 lakh people suffers from this disease. Therefore, every month, some GBS patients come to major hospitals / medical colleges in Mumbai for treatment. In the past few years, this disease has exposed the negligence of millions of citizens of Pune in providing water without purification. This disease is not contagious; but it spreads due to contaminated water. Diarrhea, nausea, vomiting, fever, are some of its symptoms. These symptoms are seen in many diseases; but the muscles of some GBS patients gradually relax, they stop working and this leads to temporary disability; It is experienced that if these patients have some other diseases, complications increase and the risk increases. It is the job of the health system to provide these patients with proper treatment, while it is the job of the municipality to remove the root cause of the disease, the contaminated water, and supply clean water. However, the high cost of treating patients and the lack of water purification projects in the relevant areas have made it difficult to control the situation. Due to this, public anger is increasing there The entire Pune gets its water supply from the Khadakwasla dam. Yet, the system has failed to create a system for the supply of clean water in this area. Even today, water is supplied there through local wells, and it was admitted in front of Health Minister Prakash Abitkar. It is true that the villages in this area have recently been included in the municipal corporation; but this cannot be said to be the reason for not arranging water purification. After the outbreak of 'GBS', leaders and administrative officials visited the wells in Dhayari and Nanded. If they had inspected these wells and made arrangements earlier, perhaps the spread of 'GBS' could have been prevented 'GBS' has also raised questions about the unplanned urbanization of Pune. Education and employment are leading to migration to Pune from all parts of the state and even from across the country. The total population of the Pune Metropolitan Authority area has now crossed the 50 million mark. To accommodate such a large population, it will not only be possible to increase the area; facilities have to be created for them as well. 'GBS' has highlighted the infection of inefficiency and carelessness in our public systems. If this infection is removed, it is relatively easy to overcome other infections.

The ultrasound centre, where the sex determination test was conducted, has been sealed, and an FIR has been registered. An amount of Rs 26,800 was recovered during the raid."A team led by Dr Vishvjeet Rathee, District Nodal Officer (PC and PNDT), raided the Global Diagnostic Centre in Meerut. Radiologist Dr Chavi Bansal and touts Anil, Pawan and Hemender were arrested," said Dr Ramesh Chander, Civil Surgeon, Rohtak. "The radiologist conducted the ultrasound examination of the decoy patient without filling the mandatory Form-F and informed her about the gender of the foetus, following which the doctor was nabbed," said Dr

Temperature rises above normal in state

Hisar : With the daytime temperature rising higher than normal by about 2°C to 5°C in various parts of the state, agriculture experts have issued an advisory to farmers to take measures to protect rabi crops, especially wheat. The average normal temperature should remain between 22°C to 23°C. Dr Om Prakash Bishnoi, wheat scientist from Chaudhary Charan Singh Haryana Agricultural University (HAU), Hisar, said it took 90-95 days for the wheat earhead to emerge and 42-45 days for grain filling, but higher temperatures might shorten this period, potentially reducing grain quantity and yield.He said an increase of temperature by 1% above normal could bring down the yield by 6-7%. However, the Indian Meteorological Department (IMD) said there had been a further increase of 3.6°C in average maximum temperature in the state, leading to concerns among farmers due to its impact on wheat crop.



Dr Bishnoi said to counteract the effects of higher temperatures, farmers were advised to spray 2 kg of potassium nitrate dissolved in 100 litres of water per acre. This helped the crop tolerate heat stress and supported grain development. Besides, timely irrigation at critical stages, zinc application, and white control measures rust should be followed to sustain yield potential. The farmers should stay updated with weather forecasts and adopt necessary precau-

tions, he added. Meanwhile, the highest maximum temperature of 30.9°C in the state was recorded at Hathnikund Barrage in Yamunanagar district. The average minimum temperature has increased by 0.6°C, though it remains near normal. The lowest minimum temperature of 7.3°C was recorded at Saragthal.Dr Bishnoi said lower nighttime temperature was a relief for the crops. "If the night-time temperature rises above 15°C, it may harm the crops," he said, adding

that a meeting chaired by Research Director Dr Rajbir Garg was held to formulate crop advisory.

In the last week of January and the first week of February, two to three western disturbances occurred, but no rainfall was recorded, which decreased the humidity in the air, leading to a rise in temperature. If snowfall occurred in hilly regions, night-time temperatures would remain low. Rainfall in the state could also help in reducing the temperature, said experts.

FDA cracks down on online sale of MTP kits, 227 seized in raids

Chandigarh : In a major crackdown on the illegal online sale of (MTP) kits, a team from the Food and Drug Administration (FDA) and the Health Department raided pharmacies in Ghaziabad and Badaun (Uttar Pradesh), seizing 227 MTP kits being sold unlawfully. The operation was launched on the directions of ACS Health, Sudhir Rajpal, who had instructed State Drug Controller Manmohan Taneia to curb the unauthorised sale of MTP kits.As part of the crackdown, a decoy operation was conducted by Amandeep, (DCO), Gurugram, who placed an online order for MTP kits. Upon receiving payment, the online pharmacies — operating from Ghaziabad and Badaun -dispatched the kits under the brand name "Unwanted" to the DCO's official address, along with instructions on how to use them for abortion. Taneja emphasised the legal restrictions on MTP kits, stating: "The MTP Act 1971 & Rules 1975 allow medical termination of pregnancy up to nine weeks using MTP kits only under the supervision of a Registered Medical Practitioner (RMP) and in an approved MTP



centre."Following the operation, FIRs were registered on February 11 under the MTP Act, (BNS) and the Drugs and Cosmetics Act at Sector 40 police station in Gurugram. The suppliers identified in the investigation include: Satyam Tripathi Office, Ghaziabad, M/s Baba Shyam Store, Badaun and M/s Apurva Mfg Group of Companies, Badaun. Taneja highlighted the serious health risks posed by illegal MTP kit usage, saying: "Many pregnant women who ingested these kits unlawfully at home had to be rushed to government health centres in life-threatening conditions. Their lives were saved by doctors and based on their statements, FIRs were filed against suppliers.

These cases are under trial in various courts."FDA teams, along with police and health officials, raided the supply points to investigate further At the Ghaziabad pharmacy officials seized 191 MTP kits and the owner was arrested for illegally supplying the kits without any records of acquisition.In Badaun, the police team found 36 more MTP kits intended for unlawful distribution. Officials confirmed that the pharmacy had been involved in the large-scale illegal supply of such kits. ACS Sudhir Rajpal noted that since 2015, more than 1,220 FIRs have been registered under the PC-PNDT and MTP Acts to prevent illegal abortions and protect the girl child in the state.

Anti-corruption bureau opens office in Palwal amid rising bribery cases

Faridabad : In response to rising corruption cases in the region, the Anti-Corruption Bureau (ACB) has opened a branch office in Palwal, marking the second such unit after Faridabad. This move follows the detection of 26 bribery and corruption cases across Faridabad and Pal-

wal districts over the past year. A senior ACB official stated that the new office would provide easier access for complainants who previously found it difficult to approach the Faridabad office. The Palwal unit, located in Rehra-

na village near the Mini Secretariat, will be headed by a DSP-rank officer and supported by six personnel, including an Inspector.

Inaugurating the office on Tuesday, ACB SP Jaiveer Rathi said, "This facility will enable citizens to report corrupt officials more conveniently.

It will not only save time and money for complainants but also help the department take swift action." He emphasised that the the ACB has uncovered 26 corruption cases in the region, with six FIRs registered in the past 45 days. These include three cases in Palwal, two in Faridabad and one in Gurugram

1800-180-2022 for citizens to report corruption.Last year, five police personnel were dismissed from service in Palwal after being found guilty of corruption and misconduct. The officials included two sub-inspectors, two assistant sub- inspectors and one constable.

An official from the Police Department confirmed that these dismissals followed departmental inquiries, which found them guilty of taking bribes and other irregularities while on duty.

NHAI awaits utilisation report for green corridor along Delhi-Mumbai Expressway in Faridabad

Faridabad : Even as the 24-km passage of Delhi-Mumbai Expressway, which passes through the city, has become operational, the (NHAI) is yet to receive the utilisation certificate for the work related to compensatory plantation along the corridor. The NHAI had released funds to the tune of Rs 5 crore for the work nearly three years ago. According to sources in the NHAI and district administration, though the part two of the expressway connecting Mithapur (Jaitpur Pushta) on the Delhi border and in Kelly village of Ballabhgarh subdivision in the district has been made functional, the issue of compensatory plantation or the proposal of development of a green corridor along the expressway is a cause for concern as the department concerned is yet to submit the compliance report of the project, for which funds

Doctor shortage hits Emergency Wing at Faridabad Civil Hospital

Faridabad : The emergency wing of Faridabad's 200-bedded Civil Hospital continues to grapple with severe doctor shortage and it is operating with only two medical officers instead of the required six. Despite appointments by the Health Department, six doctors have failed to join duty, exacerbating the crisis.

To cope, the hospital has been deploying field doctors on deputation, but insiders reveal that this temporary fix is insufficient. "The Casualty section requires at least six doctors, but it has been relying on just two to three doctors, leading to patient care challenges," a hospital employee said on the condition of anonymity. The situation becomes



critical at night, when doctors are often unavailable to treat serious cases. Additionally, a shortage of General Duty Assistants (GDAs) further strains hospital operations. Information obtained under the RTI Act by local resident Ajay Saini revealed that six appointed doctors

Three months on, Rohtak performing arts varsity's contractual faculty awaits salaries

Rohtak : Contractual faculty members of Dada Lakhmi Chand State University of Performing and Visual Arts (DLC-SUPVA), Rohtak, have not received their salaries for up to three months. Some of these staffers last received salaries in November last year.

DLC-SUPVA comprises Film and TV, Visual Arts, Design, and Town Planning and Architecture departments, at which nearly 35 adjunct and guest faculty members are employed on a contractual basis.

The contractual teachers of Film and TV faculty have not received their salaries for three months, and those from the remaining faculties have been awaiting their salaries for two months.

Contacted for comments, DLC-SUPVA Registrar Dr Gunjan Malik Manocha said the delay in disbursement of salaries to contractual faculty members had been caused due to the delay in the appointment of a Vice-Chancellor

"However, Shree Prakash Singh has now assumed charge as the Vice-Chancellor, and salaries will be released within a week after the completion of the official procedure in this regard," she added.

DLC-SUPVA Teachers' Association president Indranil Ghosh said having to work without receiving salaries for the past few months had been quite challenging for contractual faculty members.

Jail inmates' products draw crowds at 38th edition of Surajkund craft mela

Faridabad : The ongoing 38th edition of Surajkund International Craft Fair here showcased several items prepared by jail inmates and their families, attracting many visitors from across the country. The fair began on February 7, and will run up till February 23.

Gurugram's garbage woes take centre stage in civic polls

Gurugram : As Gurugram prepares to elect its civic representatives after a 27-month hiatus, the waste management crisis — a key issue in the last election continues to plague the city. With 36 wards comprising villages, builder colonies and HSVP sectors, garbage disposal and sanitation have emerged as major concerns in over 20 wards, making it a central election issue. The problem is most severe in rural areas, particularly in Ward 20, home to Bandhwari village, which hosts the city's infamous landfill site. Every day, over 1,200 metric tonnes of waste is dumped here, leading to severe health and environmental hazards. Though the Municipal Corporation Gurugram (MCG) has deployed vendors for waste treatment, legacy progress has been slow, leaving garbage scattered across the ward, with residents battling stench, pollution and health risks. "Garbage defines our lives. It dictates everything — where we get water, when we sit outside, even if we let cattle roam

Persistent property ID errors in Karnal MC upset residents

Karnal: Discrepancies in property IDs within Karnal Municipal Corporation (KMC) limits remain a major issue, causing significant inconvenience to residents. Problems with ownership verification, property transfers and tax assessments persist despite multiple initiatives by authorities to rectify errors.

Errors in property IDs include name changes, incorrect addresses, mobile number updates, incorrect property size, change in category or use and status updates from unauthorised to authorised. These discrepancies have created roadblocks for residents attempting to sell or purchase properties.

The issue has been raised multiple times in the Haryana Assembly, with Opposition leaders accusing the government of negligence. Protests have been staged demanding a quicker resolution. According to official data, Karnal had 1.42 lakh property IDs in 2013. A 2019-20 survey by a private company, assigned by the Directorate of Urban Local Bodies Haryana, increased the number to 1,62,222. 1,66,584. In November 2022, KMC uploaded property ID data online for public verification and correction. Since then, over 88,000 complaints have been filed regarding incorrect entries, leaving residents struggling to get them rectified. Following the online verification initiative, the number of registered properties increased to 1.68,341. Out of the

tion. As many as 57,000 properties out of 1,68,341 have been self-verified by residents.Despite these efforts, many residents continue to struggle with property ID errors. Yashpal, a local resident, said: "The property ID of my residence was shown as commercial. Despite multiple complaints, the issue remained unresolved for several days." Bhupinder Kumar, another resident, said, 'I had to visit the MC office for months to resolve my property ID issue. Ex-Merchant Navy employee stabs daughter to death; attacks wife, mother with hammer

Rewari : Police have arrested a 40-year-old former employee of the Merchant Navy, accused of stabbing his 9-year-old daughter to death and injuring his wife and mother by hitting them with a hammer in the Mayur Vihar locality here on Tuesday night. The accused, identified as Sandeep Kumar of Hudiya Kalan village in Alwar district (Rajasthan), currently resides in a rented accommodation in Mayur Vihar in the city."On the in-

tervening night of Tuesday and Wednesday, we received information that a man in Mohalla Mayur Vihar had beaten up and injured his wife, daughter, and mother. Acting swiftly, the police rushed to the spot and found many people gathered there. A lot of blood was found scattered in the room, after which the Forensic Science Laboratory team was called to visit the scene of the crime. A knife used in the crime was also recovered from the

spot," said the spokesperson of the district police. He maintained that the accused's wife, Kusumlata, and mother, Prem Devi, said that Sandeep had stabbed his daughter, Ranvita, in the neck. Later, the girl, in critical condition, was rushed to the hospital with the help of an ambulance. The accused's wife and mother also suffered injuries in the attack and were hospitalised. Govternment committed to improve groundwater levels in dark zone blocks, says minister

Chandigarh : Union Jal Shakti Minister CR Patil has emphasised that dedicated measures are being taken to improve groundwater levels in Haryana's dark zone blocks. Speaking at a press conference alongside Agriculture and Farmers' Welfare Minister Shyam Singh Rana, he said the Central government is committed to implementing effective water conservation and recharge initiatives in collaboration with the Haryana Government.

Patil highlighted that around 150 districts across India have several blocks classified as dark zones due to severe groundwater depletion, with

Haryana among them. The ministry's goal is to help Haryana's dark zone blocks recover through rainwater conservation efforts, which, he stressed, "can only be successful with public participation."The minister revealed that in the Union Budget 2024, Haryana has been allocated approximately Rs 76,000 crore for development projects. Additionally, the state has received around Rs 78,000 crore in grants, accelerating its progress. Comparing the figures with previous governments, Patil stated: "Before 2014, Harvana received only Rs 19,000 crore in the Central budget and Rs 21,000 crore in grants. The

current allocations reflect the government's commitment to Haryana's rapid development."Patil also highlighted the PM Kisan Samman Nidhi Yojana, under which 13.8 lakh farmers in Haryana are receiving direct financial benefits. Across India, the scheme has benefited over 9.58 crore farmers. Further, he shared that Rs 3,416 crore has been allocated in the Railway budget to enhance Haryana's rail infrastructure. Key developments include 14 new projects covering 1,195 km and 34 railway stations being upgraded under the Amrit Bharat Station Scheme, with an invest ment of Rs 1,149 crore.
