

## SC begins hearing on Waqf Amendment Act: Petitioners call it Parliamentary overreach into religious rights

the Supreme Court, headed by Chief Justice of India Sanjiv Khanna and comprising Justices Sanjay Kumar and KV Viswanathan, is currently hearing over 73 petitions challenging the constitutional validity of the Waqf (Amendment) Act, 2025.

Senior Advocates Kapil Sibal, Rajeev Dhavan, AM Singhvi, and CU Singh are arguing on behalf of the petitioners, while Solicitor General Tushar Mehta is representing the Union

Opening the arguments, Senior Advocate Kapil Sibal contended that the Waqf Amendment Act interferes with the essential and integral aspects of the Muslim faith, invoking Articles 25 and 26 of the Constitution.

He submitted that the phrase "in accordance with law" in the amended provisions undermines religious practices and opens the door for legislative overreach.

The court directed that challenges be presented point by point.

Sibal began by contesting Section 3(r) proviso: 'It allows Waqf by user to remain unless in dispute or claimed by the government', which he argued dilutes the essence of Waqf.

Section 3A(2): This provision, which deals with Waqf-alal-aulad and inheritance to women, was questioned by Sibal —"Who is the State to interfere

in Islamic inheritance that takes effect only after death?'

CJI responded, noting similar laws exist for Hindu communities, and Article 26 is secular and applies to all religions.

Sibal also challenged Section 3C: government-identified properties will no longer be deemed Wagf after the Act comes into force.

Section 3C(2): Allows government to unilaterally declare such properties without a defined timeline, which he claimed is unconstitutional.

Provision on protected monuments: He argued that Waqf properties should not be invalidated merely because they

are later declared ancient monuments. To this, the CJI observed that Waqf status would remain intact if declared

## "You can't rewrite past": SC slams State over Waqf Amendment amidst Murshidabad unrest

New Delhi: In a high-stakes constitutional showdown over the Waqf (Amendment) Act, 2025, the Supreme Court on Wednesday expressed deep concern over reports of ongoing violence in West Bengal's Murshidabad district linked to the

"One thing is very disturbing the violence that is taking place. If the matter is pending here, it should not happen," remarked Chief Justice Sanjiv Khanna, reflecting the bench's disapproval of street-level unrest while judicial scrutiny is underway.

Solicitor General Tushar Mehta, representing the Centre, responded: "Yes, they think they can pressurize the system by this.'

But senior advocate Kapil Sibal, arguing for the petitioners, shot back sharply, "Who is pressuring whom, we don't know. three-judge bench.

26 of the Constitution does not prohibit the enactment of laws governing waqfs but expressed reservations about certain provisions and their sweeping implications.

Among the major concerns raised was the reclassification of public trusts as waqfs some dating back a century or more.

"You cannot rewrite the past of 100 years," CJI Khanna said firmly, cautioning against attempts to

subsume long-established trusts under waqf control retroactively.

Mehta defended government's stance by citing the (Joint Parliamentary Committee) report, emphasising inclusivity: "Two members will be not be treated as waqf during a Collector's inquiry into whether it is government land will not be

on the logic of restricting Board membership exclusively to Muslims. "Clause (c) doesn't say that only two non-Muslims can be appointed," he pointed out. Mehta responded that the Centre would clarify the matter through an affidavit and maintained, "This is for new Boards. Existing Boards will complete their tenure."

CJI Khanna also grilled Mehta on religious inclusivity: "Are you saying Muslims can now be appointed to Hindu Endowment Boards too? Say it openly." The SG quipped, "Then this bench cannot hear the case!"prompting the CJI to retort: "When we sit here, we lose our religion. Both sides are the same for us."

The heated exchange in the Courtroom veered into historical territory as the bench questioned the retroactive application of waqf status to properties governed by public trust

Sibal emphasized the absence of a functioning Central Waqf Council historically, while the SG cited past judgments including one from the Hyderabad Nizam era supporting the coexistence of trusts and waqfs.

However, the CJI was unrelenting: "If a public trust was declared waqf

200 years ago, how can it now be reclaimed or reversed by the Waqf Board?"

The Court then issued a notice and directed all parties to file their responses. The matter will

### SC questions Muslim-only clause in Waqf Amendment Bill: 'Why not non-Muslims on Waqf Boards?'

New Delhi: The Supreme Court today continued its intense hearing on the constitutional challenge to the Waqf Amendment Bill, raising sharp questions over inclusivity, historical reinterpretations, and the scope of Waqf board

own faiths.

The hearing will resume tomorrow, but not before a stormy exchange unfolded in courtroom between Solicitor General Tushar Mehta and a Bench led by Chief Justice of India Sanjiv SG Mehta defended the

amendment, stating, "The bill wasn't brought overnight. A Parliamentary Committee (JPC) was formed, all stakeholders were heard, and the report is in the domain." highlighted the amendment's intention to make Waqf boards more inclusive, that two pointing members on the board will mandatorily be women.

However, Justice Sanjay Kumar raised a critical query: "Why must the members Clause Muslims?" specifically Mehta responded, "Because there is a choice." But Justice Kumar insisted, "We have to go by the wording. If only Clause (c) mentions Muslim members, the rest can be non-Muslims too.'

The bench also grilled the religious

SG on the retrospective impact of the amendment. CJI questioned, "Where a public trust was declared as Waqf 100 or 200 years ago, how can the board now claim it? You cannot rewrite the past!"

SG Mehta tried to clarify: 'If a Muslim creates a trust today, it doesn't necessarily have to be a Waqf. There's a five-judge judgment from Hyderabad Nizam's era Hyderabad allowing such trusts."

To this, the CJI shot back, Then you are undoing that judgment too."

A pivotal moment came when the CJI provocatively asked, "Mr Mehta, are you willing to say that from now on, Muslims can also be of members endowment boards?"

SG Mehta deflected but offered to file an affidavit stating that apart from two exofficio members, only two others would be Muslims.

Justice Khanna reacted strongly to a comment by SG judges with comparing representatives:

"When we sit here, we lose our religion. Both sides are equal to us. Don't compare this to judges.

Meanwhile, Vishwanathan pointed out practical aspects: "There are issues like ingress/egress in mosques. So, naturally, some members must be able to visit and relate to the premises.'

The Bench emphasised that JPC reports cannot override the actual wording of the Act, and insisted that the proviso in Clause (c) doesn't restrict the other members from being non-Muslims.

Finally, the CJI remarked on the broader implications: "When the constitutional validity of a law is pending before us, High Courts cannot decide it. Either we hear it ourselves or take all related cases here."

Both SG Mehta and Senior Advocate Abhishek Manu Singhvi (appearing for petitioners) urged the SC to hear the matter directly and resolve it in a time-bound

## Cong holds protest against ED action in National Herald case

**New Delhi:** The Congress on Wednesday held a protest here the Enforcement against Directorate (ED) for filing chargesheets against Sonia Gandhi, Rahul Gandhi and other Congress leaders in connection with the alleged money laundering case related to the National Herald.

Talking to reporters, party general secretary Sachin Pilot said that there was no substance in the National Herald case and called it "politically motivated". He alleged that the Modi

Moreover. Congress spokesperson Supriya Shrinate labeled the entire matter a "conspiracy" orchestrated by the BJP. She claimed that the BJP, driven by fear, was engaging in "vindictive and dirty politics," and asserted that the grand old party would "challenge the BJP's propaganda in court."

Congress Devender Yadav said that the government Modi

intimidate Rahul Gandhi or the Congress party by filing "false chargesheets." "Every worker will stand strong in this fight. Today the situation in the country is such that anyone who raises voice against the government, attempts are made to suppress him," he said. "Dr. B. R. Ambedkar drafted this Constitution for the entire nation. The BJP must understand that it belongs to India, not to any one party. You may be forcibly taking away my rights, but this cannot go on forever," she said.

#### Delhi's Dwarka court receives bomb threat via email

New Delhi: A bomb threat email led to the evacuation of the Dwarka court complex in Delhi on Wednesday morning, prompting an extensive search by security teams. According to police, a PCR call reporting the threat was received at around 10:45 a.m., indicating that the court had been sent a bomb threat via email. The message was reportedly received the previous night around 9 p.m., but court authorities only notified law enforcement the following morning.In response, bomb disposal units and sniffer dog squads were deployed to the location. "We are conducting a comprehensive search of the premises, and so far, no suspicious items have been found," said a senior police official.

#### 4 held, including two minors for stabbing Delhi SI police

New Delhi: Delhi Police have taken four individuals into custody, including two minors, in connection with the stabbing of a 53-year-old sub-inspector in the Azadpur area of Northwest Delhi. The victim, Prempal Diwakar, who lives with his family in Azadpur, is attached to the Police Control Room unit under the North East Zone in Wazirabad.Authorities received an emergency call about the stabbing around 7:20 p.m. last Friday. Responding officers arrived at the scene to find Diwakar near his home with multiple stab injuries to his abdomen. He was immediately given medical assistance. During a preliminary inquiry, Diwakar reportedly named one of the individuals involved, which allowed investigators to quickly launch a search operation. Multiple police teams were formed, leading to the arrest of four suspects after coordinated across various locations.A senior police official stated that, according to the accused, the confrontation began near a railway track close to the sub-inspector's residence. They claimed that Diwakar allegedly threw something at them, triggering a heated argument that spiraled into a violent altercation and ended with the stabbing.The investigation is still underway as police work to piece together the exact circumstances that led to the as-

#### Rajasthan man who duped 150 people in Rs 19 lakh ponzi fraud held

New Delhi : A man from Sri Ganganagar, Rajasthan, identified as Vinod Kumar, has been arrested for allegedly duping around 150 individuals through a fraudulent investment scheme named Dollar Win Exchange. The scam was exposed after an online complaint was lodged at the cyber police station in Delhi's central district by a man who claimed he lost ₹19 lakh.The complainant told police he had joined a WhatsApp group promoting an investment opportunity that guaranteed up to 28% returns per month. He and his wife initially earned modest profits after investing as little as ₹1,000, but were later persuaded to deposit larger amounts. Eventually, the returns stopped coming. Following the complaint, a case was filed and Kumar was tracked down and arrested. According to Deputy Commissioner of Police (Central) M Harsha Vardhan, Kumar disclosed during interrogation that he had previously worked for six years in the marketing division of a cooperative society. After the company shut down in 2016, he ventured into cryptocurrency trading, where he suffered financial setbacks.

## "Will Muslims Be On Hindu Boards? Say It Openly" Supreme Court To Centre

New Delhi : Hearing the bunch of petitions challenging the Waqf Amendment Act, the Supreme Court today asked the Centre tough questions on multiple provisions of the new law, especially its provisions for 'Waqf by user' properties. The court also flagged the provision to include non-Muslims on the Central Waqf Council and asked the government if it would allow Muslims to be part of Hindu endowment boards.

The bench, led by Chief Justice Sanjiv Khanna and comprising Justice Sanjay Kumar and Justice KV Vishwanathan, was hearing 73 petitions challenging the new Waqf Act, which has sparked protests in several parts of the country.

At the outset, the Chief Justice told the petitioners that two questions needed to be addressed. The first was whether the Supreme Court would send the petitions to a high court and what points the petitioners intend to argue.

Senior Advocate Kapil Sibal, appearing for one of the petitioners, said many provisions in the new law violate Article 26 of the Constitution, which guarantees the freedom to manage religious affairs. Mr Sibal also flagged the pow-



ers the new law gives to the Collector. He argued that the Collector is a part of the government and if he plays the role of a judge, it is unconstitutional.

Mr Sibal then mentioned 'Waqf by user' - a provision under which a property is treated as Waqf based on its long-term use for religious or charitable purposes, even without documentation. The new law adds an exemption: this won't apply to properties that are in dispute or are government land.Mr Sibal said that 'Waqf by user' is an integral part of Islam. "The problem is, if a waqf was created 3,000 years ago, they will ask for the deed," he said.Senior Advocate Abhishek Singhvi, also appearing for a petitioner, said that 4 lakh Waqf properties out of the total 8 lakh properties in the country are 'Waqf by user'. At this point, the Chief Justice intervened, "We are told

concern," he said. Mr Singhvi then said they are seeking a stay on some provisions and not the entire Act.

Appearing for the Cen-Solicitor General Tushar Mehta said the law was passed after detailed and elaborate debates in Parliament. He said a joint

parliamentary committee examined it and it was passed by both Houses

The Chief Justice then asked Mr Mehta to focus on the 'Waqf by user' provisions in the new law. "Are you saying that if a 'Waqf by user' was established by a (court) judgment or otherwise, today it stands void?" The Chief Justice mentioned that many mosques part of Waqf were built in the 13th, 14th and 15th centuries and it is impossible to present documents for them.The bench then said that "there will be an issue" if the government is going to denotify 'Waqf by user'. "The legislature cannot declare a court's judgment would not be binding," it said, adding that while there are instances of "misuse", "there are genuine

How will you register such 'Waqfs by user' who have been there for long? What documents will they have? It will lead to undoing something. Yes, there is some misuse. But there are genuine ones too. I have gone through the Privy Council judgments. 'Waqf by user' is recognised. If you undo it, then it will be a problem," the Chief Justice said.

The court then moved to the composition of the Central Waqf Council under the new law. The Chief Justice then asked a significant question. "Mr Mehta, are you saying you will allow Muslims to be part of Hindu endowment boards? Say it openly"

The Chief Justice also noted that it was "very disturbing" that violence was taking place over the new law. Mr Mehta then said "they think they can pressurise the system". To this, Mr Sibal replied that it is not known "who is pressuring". The Chief Justice noted that the positive points in the law must be highlighted. The matter will be heard again tomor-

#### SC rejects plea to make Section 498A gender neutral, Says law must protect women from matrimonial cruelty

New Delhi: The Supreme Court on Tuesday declined to entertain a plea seeking to make Section 498A of the Indian Penal Code (now Section 85 of the Bharatiya Nyaya Sanhita) gender neutral, stating that isolated instances of misuse cannot justify changes to a law enacted to safeguard women from cruelty in matrimonial homes.A bench comprising Justices Surva Kant and N. Kotiswar Singh observed, "Just because of certain instances of misuse of Section 498A of IPC and Section 85 of BNS, can a sweeping statement be made that women are harassing their husbands and in-laws? Nothing can be further from the

### Supreme Court Considers Interim Stay On Parts Of Waqf Act, Centre Pushes Back

The Supreme Court's intention to issue an interim order on the amended Waqf law was put on hold at the last minute today after the Centre and the states requested more time to marshal their arguments on the three points the court

The three-judge bench led by Justice Sanjiv Khanna will hear the matter again tomorrow.

The top court, hearing a bunch of petitions challenging the amended law, had expressed concern about the violence sparked during protests. It also questioned if Muslims would be included in Hindu religious boards.

At the end, the judges raised three points, indicating their intention to pass an interim order, putting some provisions of the amended law on hold. For all three procedures -- on which the rules have been amended -- the court expressed its intention to maintain status quo.

Whatever property has been declared as Waqf by the user, or declared by the court, will not be notified, the judges said. Secondly, the Collector can continue the proceedings, but the provision will not be applicable. Third -- while ex-officio members can be appointed regardless of religion, others should be Muslims, the judges said.

"Normally we don't pass such interim orders, but this is an exception," said Justice Khanna, pointing out that the hearing can go on for six to eight months.

At this point, the centre and the states objected against an interim order and sought more time.

### Desperate For Child After 7 Years Of Marriage, Delhi Woman Steals Newborn The one-day-old girl was stolen from Safdarjung Hospital

According to officials, a man from Yashwant Place in Chanakvapuri called the police control room around 4 PM on Tuesday, reporting that an unidentified woman had taken his newborn daughter from Safdarjung

Hospital. He explained that his wife had delivered the baby at the hospital just a day earlier.

Police reviewed surveillance footage from the hospital and nearby areas, eventually spotting a woman behaving suspiciouslyspeaking to several patients and later leaving the premises with a baby in her arms. The CCTV clips revealed that she boarded a train at the AIIMS metro station and made several route changes, likely in an attempt to mislead investigators. The suspect was seen getting off at Hauz Khas metro station and taking an

auto-rickshaw. By tracking down multiple auto drivers, the police found one who confirmed he had driven her to Gullak Wali Gali in Malviya Nagar, South Delhi.Police then located the suspect's residence and took her into custody. She was identified as Puja Patni. During questioning, Patni confessed that she had told her husband she was pregnant and left home on Monday under the pretense of getting hospitalized. She returned the next day with the abducted newborn.

#### ED conducts multi-state searches in Mahadev betting case

New Delhi : The Enforcement Directorate Wednesday (ED) on launched a new round of searches in connection with the ongoing money laundering probe tied to the Mahadev online betting app, with locations across several states being raided, including properties linked to Ease-MyTrip founder Nishant Pitti, officials confirmed.

The raids spanned multiple cities—Delhi, Chandigarh, Mumbai, Ahmedabad, Indore, Jaipur, Chennai, and Sambalpur-targeting various individuals and premises allegedly associated with the case.

The ED officially ac-

knowledged that sites connected to Pitti, who also serves as chairman of the travel booking portal EaseMyTrip, were among those examined during this latest opera-

The Mahadev betting app investigation has previously drawn national attention due to claims that influential politicians and senior bureaucrats from Chhattisgarh were implicated in illicit activities and financial dealings related to the platform. This isn't the first time the ED has conducted such searches; multiple operations have taken place earlier as part of the broader probe.

## Woman, 20, shot dead in east Delhi, kin suspect 'social media friend'

New Delhi : A 20-year-old woman was fatally shot on Monday night in East Delhi's GTB Enclave, in what police believe may involve a man she had rebefriended cently through social media. Authorities have identified a suspect and are working to apprehend

They are also examining the possibility that the victim may have been a witness in a murder case from the previous year.

The deceased, identified as Sayra Parveen, lived in Sunder Nagri's Kaudi Colony. Around 9:55 p.m., a PCR call alerted the GTB Enclave police station to a shoot-

Responding officers found her body in a service lane near the MIG flats in Sunder Nagri.

"She sustained two gunshot wounds—one to the left side of her head and another just below the back of her neck," a senior officer reported. A used cartridge was also recovered from the scene. Police have registered a case under Section 103 of the Bharativa Nyaya Sanhita (BNS), which deals with mur-CCTV footage from

the area reportedly shows Parveen walking alongside a man shortly before the shooting. According to investigators, the two appeared familiar and were seen conversing. However, an argument seems to have broken out, followed by a brief chase between the two.

They eventually entered a poorly lit service lane, where the fatal shots were fired.

Parveen lived with her siblings. Her sister, Shahida, said Parveen left that evening, saying was meeting friends-a common oc-

#### Those who support Rana, Choksi should also be tracked down!

After India succeeded in extraditing Pakistani terrorist Tahawwur Rana, an accused in the 2008 Mumbai attacks, the arrest of notorious diamond merchant Mehul Choksi in Belgium, who defrauded Punjab National Bank of Rs 13,500 crore, is a hopeful and heartening piece of news. The arrest was made at the request of the Central Bureau of Investigation (CBI) and India has initiated the formal process for his extradition. This is the same Mehul Choksi, who took loans from foreign banks on the basis of fake letters of undertaking and, along with Nirav Modi, defrauded Punjab National Bank of thousands of crores. Some employees of the bank were also complicit in this entire case. Choksi fled India as soon as the scam was exposed. He obtained citizenship of that country by investing in the small island of Antigua and Barbuda. He was constantly accused of political patronage and legal evasion. The Indian government has been pursuing his extradition with Dominica, Antigua, and now Belgium at both the diplomatic and legal levels. Choksi was currently living in Antwerp, Belgium with his wife Preeti Choksi. It has been revealed that he used fake documents to obtain an 'F residency card' there. Citing this, the Indian government has formally sought his extradition from Belgium. At the same time, Choksi has filed an application for bail in a Belgian court on health grounds. This is the same stance he took while in Dominica. Refusing to return to India on the pretext of ill health. But now the Indian government has gathered evidence against Choksi and coordinated through the CBI, ED and the Ministry of External Affairs. The ongoing efforts to bring him back to India show the strength of Indian diplomacy and the coordination of law enforcement agencies. However, a major and neglected aspect of this entire case is the 'Shukracharva in Zari' who contributed to Choksi's crime. What about the officials who helped him by sitting in the banking system? They should also be dealt with with equal force. Because this is not just a financial crime, but a serious form of betrayal of the country. Bringing Mehul Choksi back to India and taking legal action against him is no longer just a formality, but an opportunity to prove the competence of the country's judicial system. The will shown by the government and this campaign conducted at the international level are remarkable. But the real responsibility begins now. To bring Choksi to court, present evidence against him, and bring his supporters to justice. Because Mehul Choksi is a face, but behind him there are many hidden faces, who are even today preparing the ground for the emergence of new Choksis in some institutions, chairs, and ministers. Only if all such people are found and held accountable, will Mehul Choksi's arrest truly

One of the biggest financial scams in the history of Indian banking is the Punjab National Bank scam of Mehul Choksi. This scam raised serious questions about the credibility of the country's financial and legal system. The main accused in this case, Mehul Choksi, had been hiding abroad for many years. This scam was not a simple one. It was an attack on the financial discipline and vigilance in the Indian banking system. Mehul Choksi, in collusion with some employees of the bank, defrauded the bank of Rs 13,500 crore and fled India. His escape posed a major challenge to the Indian system and the government as a whole. Mehul Choksi was trying to evade all the charges against him and avoid legal action by staying abroad. Efforts are underway to extradite him. Many criminals like international smuggler and underworld don Dawood Ibrahim, onetime liquor baron Vijay Mallya should be brought to India. All Indians feel that they should be tried and punished.Common people look at such criminals and the crimes they have committed in a very different light. They feel that if a small installment of a bank loan is missed or missed, the bankers come to the doorstep of the common man. They harass people by calling them on the phone and scam people worth ten, twenty, thirty thousand crore rupees, but such people are not arrested or even taken action against them. They flee abroad and live happily ever after. It is not for nothing that the common man feels that justice is equal for all, but in reality it is not like that. Even in the context of the judiciary, the common man does not have a very good feeling in his heart. The reason for this atmosphere is the free rein given to many criminals in the past. In such a situation, the common man feels satisfied that whether it is Tahawwur Rana or Mehul Choksi, they will be shown the whip of the law. The Narendra Modi government at the Center, his cabinet colleagues and the central machinery have all created a sense of hope in the minds of Indians. All the investigating agencies should take care that this hope does not turn into despair. There have also been reports that Mehul Choksi has revealed the cause of some serious illness and has informed that he is undergoing treatment for it. Whatever the illness may be. But, that is not the reason to show mercy to such criminals. We cannot forget that the Punjab National Bank scam also happened with the connivance of some employees there. Therefore, all such sukracharyas in the Zari should also be found and crushed. Ultimately, this issue is not limited to this one bank. It is a question of the nation's illusion and the aspirations and expectations of the common people. Therefore, they should be brought to India as soon as possible and the case against them should be tried in a fast-track court. Only if they are given birth

#### Three die in two road accidents in Sirsa's Rania

Sirsa: Three people lost their lives in two separate road accidents in Rania of Sirsa district on Monday night. The bodies of the deceased were sent to the Civil Hospital in Sirsa for a post-mortem examination. Based on the statements of the victims' families, the Rania police have registered separate cases and started investigations. In the first incident, Vijay Singh, a resident of Kussar village, died at around 9 pm in a road mishap.Vijay was married and had two children. He owned a grocery shop. According to a police report filed by his cousin, Rajroop, Vijay was returning home from his shop on a motorcycle. While he was near Mahawat Seeds, a speeding car hit his bike from behind. He suffered serious injuries and was taken to Civil Hospital, where doctors declared him dead on arrival. In the second incident, two youngsters from Naiwala village, Sahil and his cousin Vijay, died after being hit by an unidentified vehicle They were returning home after attending a wedding. Gurugram: The police have arrested the live-in partner of a woman whose body was found wrapped in a blanket in a field in Naharpur village on March 11. The breakthrough came while investigating the blind murder case, which had initially left no clear leads. The arrested man has been identified as Shivshankar Sharma, also known as Kalicharan, a native of Ballia in Uttar Pradesh He was arrested from Naharpur village on Monday. During interrogation, the accused reportedly admitted to murdering the woman, suspecting she was having an affair with another man. The woman's body, wrapped in a blanket, was discovered in a wheat field in Naharpur village. The police placed the unidentified body in the mortuary and it was only on March 31 that the woman was identified as Rita, a resident of Bihar, by her father. Following this, an FIR for murder was registered at the Manesar police station. In his complaint, Rita's father stated she was married 11 years ago and had moved to Naharpur village in Gurugram about five years back with her husband. However, due to a dispute, her husband left her and she began living with Shivshankar Sharma in a live-in relationship."I last spoke to Rita on 23 February. I later came to Naharpur to meet her and heard that a woman's body had recently been found in the fields. ## Teachers rue updating diary on MIS portal

rectorate of School Education's direction to government school teachers to update the teacher diary on MIS (Management Information System) portal of the Education Department has not gone well with the teachers.

Government teachers in Kurukshetra have given a call of holding a protest against the department's direction on April 17 at the district headquarters . Earlier, the teachers used to fill their diaries manually but from April 9, the department had implemented the decision of filing diary on the MIS portal online. In a letter issued, the directorate had mentioned that the teachers' diary was being made available through the MIS portal and the teachers must update their diaries regularly even if they were on election duty, exam duty, training or attending workshop.

The school heads were directed to issue completion certificate every month stating that all teachers had submitted their diaries online. The district-level officials were provided dashboards to check the progress. Dr Tirshem Kaushik, district president of the Haryana School Lecturers Association (HSLA), said, "The government school teachers were already updating the diaries



manually and the teachers never raised any objection. But the directions regarding updating the diary online on the MIS portal is not acceptable. The teachers are already overburdened and such directions will waste a lot of time. Moreover, this is not possible at all in practical terms."

"A teacher teaching different classes will not be able to update the diaries of all subjects on the MIS portal daily. The teachers share all details with the school heads and the department can take all required information from the school heads. The department should withdraw the orders. The Education Department should understand the ground realities and make policies by communicating with the teachers," he added. Kaushik said it had been decided to hold a protest on April 17 at the district headquarters to mark our resentment. All teacher unions would jointly hold the protest. During the demonstration, a memorandum would be submitted to the Director of Secondary Education through the District Education Officer. It had also been decided that a joint meeting of all the unions would be held to decide the future course of action. Haryana Adhyapak Vidyalaya Sangh (HVAS) district president Virender Singh said, "The department has been trying to keep the teachers engaged in noneducational work in the name of digitisation. Systems like teacher diary on MIS portal will affect the quality of teaching work. We want teachers to be able to focus on their main work of teaching and not get entangled in unnecessary technical formalities."

## **Atal Kisan-Mazdoor Canteen** inaugurated in Ambala

Kurukshetra: Haryana Transport, Energy And Labour Minister Anil Vij on Tuesday inaugurated 'Atal Kisan-Mazdoor' canteen at the New Grain Market in Ambala Cantonment.

Operated by women self-help groups (SHGs), the canteens will serve nutritious meals to farmers, labourers and needy at just Rs 10 per plate, from 11 am to 3 pm daily. As per the information, the canteen will be operated by four women belonging to Khatauli village.Cabinet Minister Anil Vij said, "Atal Kisan-Mazdoor canteen has been inaugurated for the farmers and labouers at the grain market. While the canteen will charge Rs 10 per plate from the farmers and labourers, the remaining balance of Rs 15 per plate will be borne by the market committee. Similar canteens are being opened in other grain markets too." While addressing the people present on the occasion, Anil Vij said, "The shifting of grain market in Ambala Cantonment was one of our major and initial projects. Earlier, there used to be a small grain market in the congested area of Sadar Bazar in Ambala Cantonment due to which the residents used to face inconvenience. Due to the shortage of space, very little quanti-



ty of produce used to arrive. But after the BJP formed its government, the grain market was shifted and established along the

national highway.' "The grain market is doing well and a huge quantity of produce reaches here in every season, and it is beneficial for the farmers, labourers and the commission agents working in the grain market. It already has the facility of a rest house for the farmers and now, the canteen facility has also been started. At present, the canteen is being operated from the hall of the rest house, but the marketing board has identified a location to establish

a permanent canteen in the grain market", the Cabinet Minister said. Neeraj Bhardwaj, secretary of the New Grain Market, Ambala Cantonment, said, "Atal Kisan-Mazdoor Canteen has been started in the grain market to provide good quality food at affordable prices to the farmers and labourers. A large number of farmers and labourers reach here during the season. At present, the canteen is being run from the hall of the rest house and a budget of Rs 7 lakh has been spent on setting up the canteen. Soon a new building of the canteen will be established. All efforts are being made to get the new building be-

fore the paddy procurement season." "For the existing setup, furniture, utensils, deep freezer and other required equipment have been purchased. The same will be shifted to the new building. During the season, we are expecting that about 200 persons will get the benefit of the canteen daily and it will be ensured that people get hygienic food," he added.

## Kurukshetra cops warn people to stay away from canals

Kurukshetra police spokesman Naresh Kumar said, "There have been incidents of young boys losing their lives while swimming in Kurukshetra. The locations where such incidents have been reported in the past have been identified and directions have been issued by the Superintendent of Police to keep a close watch along the canals. Patrolling has been increased. Though warning boards are installed asking people not to swim in canals and rivers, youngsters and children continue to swim in the rivers and some end up losing their lives."



"To avoid any untoward incident, a special campaign is being run and the police officials have been asking people not to swim in the rivers, canals and village ponds, else action will be taken against them. The department has also asked the village panchayats to make

announcements in the villages in this regard", he added. In his directions to the Station House Officers, Superintendent of Police Varun Singla has asked them to keep a close watch on the canals in their respective areas. As per the directions, during the summers, the youth

come to the banks of the canal to have fun with their friends and it has often been seen that they also consume alcohol. While swimming in intoxicated condition, people often die by drowning in the canal. The police department is making every effort to prevent such incidents. People are requested not to use canals, rivers and village ponds for bathing.

As per the Kurukshetra police, warning boards are installed at major locations along the canals passing through the jurisdictions of Jhansa Police Station, Jyotisar police post, and Third Gate police post. People live ing in the villages along the canals are also appealed to cooperate with the police to prevent such incidents. If any youth is found bathing in the canal, then people should inform the nearest police station or dial 112 so that legal action can be taken against such people and lives can also be saved

#### Chawla flags 'irregularities' in Kamri road flyover work

Hisar: Nand Kishore Chawla, national president of the Sarvajan Samaj Party, has raised serious concerns over the "poor construction work" of the Kamri road flyover in

He alleged that officials of the Public Works Department (Roads and Buildings Branch), Hisar, made serious errors during the construction of the flyover, which had led to persistent problems for commuters.

Chawla alleged, "During the construction

of the flyover, officials buried a 6-inch water pipeline under the bridge. Due to a leakage in the pipeline, the underpass remains filled with water, causing immense trouble to people using the route," he alleged. He claimed that, although the original design of the underpass had a width of 16 feet, it was reduced to 12 feet by officials without any justification.

As a result, the road was riddled with large potholes, making travel extremely difficult for the public, he added. Despite repeated complaints and even informing the Public Works Minister, the issue remained unresolved, he alleged.

"Even PWD Minister Ranbir Gangwa. who is resident of Hisar, passes through the underpass, yet no action has been taken to fix the problem," he said.

Chawla criticised the incomplete state of the flyover, even after nearly four years of its inauguration.

He highlighted that rainwater from the flyover, nearby roads and the canal flowed in to the underpass due to the lack of a proper stormwater drain or rainwater outlet adjoining a banquet hall.

He said the pedestrian path alongside the flyover was also in poor condition, adding to

'Some land near the flyover, which was meant to be developed into a park, is now being used as a dumping ground due to the absence of block fencing. This has led to an atmosphere of filth and negligence in the area," "If such is the state of governance near the

PWD Minister's own house, one can only imagine the condition in the rest of Haryana,"

## Karnal residents demand stoppage of Vande Bharat at city railway station

Karnal: Residents of Karnal are eagerly waiting for the stoppage of the Vande Bharat Express (Chandigarh-Ajmer) at the Karnal railway station, which is one of the oldest stations in the region, established by the British in 1892. They have urged the government to take necessary steps for a stoppage, so that the passengers can take a fast and overnight journey to Mata Vaishno Devi in Katra, Jammu and Kashmir. They said that six to seven Vande Bharat Express train run on the Delhi-Ambala route on a daily basis, but even after being an important station, Karnal does not get the facility of a stoppage of even a single Vande

In such a situation, the stop-

Bharat train. The locals alleged that after the extension of Jammu Mail to Subedarganj in Prayagraj, Uttar Pradesh, the passengers from Karnal and nearby districts are facing difficulty in securing reservation, as a majority of the seat quota has been allocated to Subedarganj. "It has become a tough job to book a seat to Katra on the Jammu Mail, as most of the seats are taken by the passengers boarding from Subedarganj.



page of the Vande Bharat Express in Karnal is necessary for a speedy journey to Mata Vaishno Devi Darbar," said Anshul Narang, a social activist, . The issue of train stoppage has been raised on multiple platforms by the residents of the district, but to no avail so far, causing growing resentment. The locals said they had been waiting for long for the stoppages of important trains such as Shri Shakti and Vande Bharat, as a significant number of devotees from Karnal travelled to Vaishno Devi in Katra. However, due to the lack of stoppages, they are forced to travel to Ambala first to board the train, which wastes both time and fuel and causes inconvenience.

Vijay Khetarwal, a resi-

dent and social activist, said they had repeatedly raised the demand for the stoppage of these trains at the Karnal railway station, which was part of the Amrit Bharat Station Scheme announced by the Union Government. Recently, Karnal MLA Jagmohan Anand wrote a letter to Railway Minister Ashwini Vaishnaw, requesting stoppages for the Vande Bharat and Shri Shakti trains. The minister responded with an assurance that the department concerned would conduct a detailed assessment of the demand. "I have raised the genuine demand of the people of my constituency with Railway Minister Vaishnaw and Union Minister Manohar Lal Khattar. We are hopeful that the stoppages of these trains will soon be approved," said Jagmohan

As per the residents, the Karnal station is a Class "A" station and a national heritage site, but it still lacks basic passenger amenities such as lifts and escalators, particularly needed by senior citizens and women. # Rs 4,680-cr industrial cluster to come up near Hisar Airport

Chandigarh: To boost development in Haryana, an industrial manufacturing cluster (IMC) will be established near Maharaja Agrasen Airport in Hisar over about 3,000 acres at an estimated cost of Rs 4,680 crore. The cluster will be developed jointly by the Haryana Government and the National Industrial Corridor Development Corporation (NICDC).

This information was shared during a meeting held under the chairmanship of CM Nayab Singh Saini today. Civil Aviation Minister Vipul Goel was also present.

The CM apprised that the Government of India, in partnership with state governments, was developing integrated industrial corridors based on multi-modal connectivity to accelerate manufacturing



growth and ensure planned urbanisation. Under the Amritsar-Kolkata Industrial Corridor, industrial townships would be developed in six cities across seven states, with the IMC in Hisar being the largest project. The project was expected to attract investments of around Rs 32,000 crore and generate over 10,000 employment opportunities. The IMC would have modern infrastructure, including roads and a water treatment and solid waste management plants. A memoran-

tween the NICDC and the state government would be signed soon for the successful execution of the project.

The CM said of the 7,200 acres demarcated in Hisar, around 4,212 acres were occupied by the airport The IMC would be established on the remaining land. Proximity to the airport would provide a significant advantage to industries, he said. It was further said that under the Delhi-Mumbai Industrial Cor ridor, an Integrated Multi-Modal Logistics Hub was being set up on approximately 886 acres in Nangal Chaudhary. Thus, Haryana stood to gain from the presence of two ma jor industrial corridors, which would boost investment and generate employment.

## Health Department to seek police cells in all districts to curb PNDT violations

Chandigarh: In a decisive move to strengthen enforcement of the Pre-Conception and Pre-Natal Techniques Diagnostic (PNDT) Act and check the declining sex ratio, the Haryana Health Department will soon write to the Director General of Police (DGP) to seek dedicated police cells in every district headed by DSP-rank officers. These special units will be trained to conduct raids, file FIRs, and send decoy customers to expose illegal sex determination and female foeticide networks. The decision was taken during a State Task Force (STF) meeting

Additional Chief Secretary (Health). While a police department representative attended the meeting, health officials stressed the need for specialised and consistent support during operations.

"The idea is to have a team which can be specifically trained to carry out the raids. At present, we rely on the district police to provide support whenever we go for the raids. Since the teams keep changing, it becomes a bit of a challenge," said a senior official. To increase vigilance, verification of random Medical Termination of Pregnancy (MTP) cases will be conducted. Ultrasound has now been made mandatory at 12 weeks for any MTP. Reports justifying MTPs will first be verified at the district level and then randomly rechecked by the headquarters.

Cracking down on unregulated fertility services, the department will close all unregistered IVF centres. As many as 18 such centres have already been identified. Utility services — electricity, water, and

— electricity, water, and municipal services — will be snapped in such cases in collaboration with Urban Local Bodies, Power, and Public Health Departments. The STF also reviewed 'suspicious' MTP cases from 27 centres. Fi-

nal reports from district committees are expected soon. Meanwhile, data on village-level sex ratio over the past five years will be compiled to identify consistent low-performing ar-

Officials have sent notices to 12 Senior Medical Officers (SMOs) asking them to explain the low sex ratio in their jurisdictions. "We have asked for data for five years since there can be fluctuation in the short-term data," a source said. The NHM Managing Director will personally hear the SMOs, and the Director, Prosecution has also joined the Task Force for coordinated legal action.

## Haryana moots police cell in each district to curb illegal sex determination

Chandigarh: To check violations of pre-natal diagnostic techniques (PNDT), the Haryana health department will write to the state police to set up a dedicated police cell in every district headed by a DSP-rank officer, officials said. The health department, which seeks to strengthen the enforcement of the Pre-Conception and Pre-Natal Diagnostic Techniques (PCPNDT) Act, will write to the DGP for setting up these cells with dedicated teams to facilitate raids and filing of FIRs in case violations are found.

The decision was taken on Tuesday at a meeting of the State Task Force (STF) set up to take action against people involved in female foeticide.

The health department has given directions that all nonregistered IVF (in-vitro fertilisation) centres should be closed, and those with skewed sex ratio should be checked thoroughly and shut down if any malpractice was found. To identify the consistently low-performing areas, data on village-level sex ratio over the past five years will be compiled. Notably, the health department recently issued show-cause notices to senior medical officers of 12 community health centres from areas reporting low sex ratio. The move was part of the government's efforts to crack down on female foeticide in the state, officials said. The director of National Health Mission in Haryana,

Virender Yadav, who's also the convenor of the STF, said recently, "We have implementing the been strictly PCPNDT Act in the state. As a result, registrations of 300 erring MTP centres have been cancelled or voluntarily withdrawn."The other members of the STF include the mission director of National Health Mission; director generals of health services, women and child development, AYUSH and PCPNDT health and police departments; and the state drug controller. ## 15 buffaloes die after 'consuming' contaminated water from factory

Karnal: As many as 15 buffaloes died after allegedly consuming poisonous and contaminated water discharged from a factory near Nagla village on the Karnal-Meerut road. The incident occurred on Monday afternoon and their post-mortem examination were conducted on Tuesday. A panel of three veterinary surgeons was deployed to conduct the post-mortem examinations and viscera samples had been sent to the forensic science laboratory (FSL) for further analysis. As per the officials of the Animal Husbandry Department, the post-mortem of the animals indicates signs of poisoning. "We conducted the post-mortem of the animals, which indicated that they consumed poisonous

samples to the FSL to confirm the cause," said Dr Sanjay Antil, Deputy Director Animal Husbandry

rector, Animal Husbandry. The buffaloes belonged to a livestock farmer from Uttar Pradesh who had brought them to the Nagla village area for grazing. It is suspected that the animals drank water discharged from a nearby factory. A joint inspection was carried out by officials from the Animal Husbandry and Agriculture Departments. "We inspected the site and submitted our report to the police. The initial findings suggest that a poisonous substance might have been present in the water consumed by the buffaloes." said Dr Tarsem Rana, a senior veterinarian, involved in the investigation.Dr Wazir Singh, Deputy Director Agriculture

(DDA), who is among the team to inspect the factory, said it was a tragic incident and investigation was underway to determine the lapses. As per the sources. the Haryana State Pollution Control Board, Karnal office, has been asked by the higher authorities to conduct inspection and seal the unit if lapses are there. The incident has triggered anger among local farmers and livestock own-"The factory owner should have taken precautions and covered the discharge area. One buffalo costs at least Rs 1lakh,' said one of the affected livestock farmers.Tarsem Chand, SHO, Sadar Police Station, said they had registered a case against the factory owner under the relevant sections of the

## Air hostess 'raped' by staff member at pvt hospital in Gurugram

Gurugram: In a shocking incident, a 46-year-old air hostess was allegedly raped in a well-known private hospital by a staff member while she was on a ventilator in the ICU. An FIR has been registered

at Sadar police station. According to a complaint filed by the air hostess, in the presence of a legal adviser, she was staying in a Gurugram hotel for training, when she nearly drowned in its swimming pool and was rushed to a private hospital. On April 5, her husband admitted her to another private hospital in Gurugram, from where she was discharged on April 13. "On April 6, I was on a ventilator, and was sexually assaulted by a staff member. I was in an unconscious state at the time of the incident. Two nurses were also there. I

was too scared to speak. After being discharged, I told my husband about the assault, and approached the police," she stated in her complaint. An FIR was registered against unidentified staff members of the hospital today. "Taking further action in the case, the victim's statement has been recorded before a magistrate. The police team is examining the footage of the hospital's CCTV cameras and will soon identify the accused. A probe is un derway and the accused will be arrested soon," said the spokesperson for the

This is not the first such incident in Gurugram's private hospitals. In July last year, a 51-year-old woman from Kazakhstan was raped by an attendant in a private hospital. The accused was later arrested.

## Left on the tarmac: Karnal's wait for airport continues

Karnal: While Prime Minister Narendra Modi inaugurated Haryana's first official airport in Hisar on Monday, the occasion brought mixed emotions for Karnal. The city, home to one of the oldest aviation clubs in the region, continues to wait for its long-promised upgrade into a domestic airport.Since 1967, Karnal has hosted the Haryana Institute of Civil Aviation, training countless pilots. Despite its legacy and strategic location along NH-44, with easy access to Delhi and Chandigarh, the city's aspirations for an airport remain unfulfilled.Meanwhile, construction of a new airport in Am-

bala Cantt — just 70 km is nearing completion. This has triggered frustration among Karnal's residents, who feel sidelined despite the city's potential. "It should not just be developed as a domestic airport but can also be upgraded into a cargo and aircraft maintenance hub, as it has the oldest aviation club in the region.' said Col Manbeer Choudhary (retd), president of the Hotel and Restaurant Association of Haryana and former president of the Federation of Hotel and Restaurant Associations of India.

He emphasised that Karnal's airport could serve nearby Panipat — one of In-

dia's top exporters — and Kurukshetra, a key religious tourism hub, thus boosting both trade and tourism.

The dream of converting Karnal's airstrip into a fullfledged airport dates back to 2012 when the Congress-led state government first floated the idea. After the BJP came to power in 2014, then Chief Minister Manohar Lal Khattar rekindled hopes by announcing the upgrade of the Civil Aviation Club into a domestic airport on November 8 that year. However, progress was limited to renovation and runway expansion. In 2021, the High Powered Purchase Committee, chaired by the CM, approved further plans for development. Yet, substantial ground activity remains minimal. A visit by then Civil Aviation Minister Dr Kamal Gupta in June 2024 raised public hope again with a renewed promise, but since then, only a

boundary wall has come up.

Authorities state that the area of the facility has expanded from 107 to 171 acres, and the runway is being extended from 3,000 to 5,000 feet to accommodate small and medium-sized aircraft.Congress MP Deepnder Hooda criticised the lack of action, reminding that the Congress had announced upgrades for both Hisar and Karnal airstrips in

2012. "No work has been done on the Karnal airport in the past 11 years during the BJP regime," he alleged.

Responding to the criticism, Union Power Minister and former CM Khattar recently said land acquisition is complete and further expansion is in the pipeline, though more land is still needed.Political analysts attribute the delay to shifting political priorities. Hisar, which gained prominence during the BJP-JJP coalition (2019-2024),benefited from the influence of JJP leader and former Deputy CM Dushyant Chautala, who strongly advocated for the Hisar airport.

### Newly built road damaged in a month, Hisar residents demand action

Boult's ability to strike early and Bumrah's pinpoint accuracy in the closing stages have helped MI turn matches even when the odds were against them. This is the kind of contest that defines a season. Abhishek Sharma is in red-hot form, but going after Bumrah and Boult under lights at the Wankhede is a different ball game. That's where this match will be decided.Mumbai come into this fixture having edged past Delhi Capitals in a tense affair. After posting 205-5, they held off a late Delhi surge to secure a 12-run victory. The win was significant, not just for the two points but for the all-round performance. Tilak Varma continued his purple patch with another fifty, while Hardik Pandya played a blistering cameo and chipped in with two wickets. Suryakumar Yadav remains the batting lynchpin, averaging close to 48 this season.

Yet, there are concerns. Rohit Sharma has not looked fluent, while the top order has often failed to fire in tandem. With a power-packed

Vignesh Puthur and Karn Sharma have chipped in with key middleover breakthroughs, while Mitchell Santner's control has allowed others to attack around him. Boult and Bumrah, despite a few expensive overs in their last outing, remain the key to Mumbai's strategy - particularly in the last five overs.

SRH's campaign has been as volatile as their batting. After losing four matches on the trot, they turned up in style at home, rewriting the record books with a fearless batting display. Abhishek's assault was backed by Head's aggression and Klaasen's finishing, giving the team a much-needed boost.

Aniket Verma has also emerged as a surprise package, scoring quickly in the lower middle-order. However, their bowling remains a worry. Mohammed Shami has looked off-colour, while Pat Cummins has leaked runs at crucial junctures. Harshal Patel, with his variations, has managed to pick wickets, but the overall economy rates have been alarming.

Eshan Malinga has shown promise, and Zeeshan Ansari has provided control with the ball. But at a venue like Wankhede, containment alone won't be enough — wickets will be the currency.

The Wankhede strip is expected to be hard and true, offering bounce and pace for the batsmen. While seamers might get some early movement under lights, the surface tends to flatten out quickly, making chasing a preferred option. Scores over 200 have been breached several times at this ground, and both teams will be wary of setting a below-par target. Weather is expected to be hot and humid, with no rain forecast

during the match hours. Mumbai have had the upper hand in recent encounters, winning three of their last four meetings with SRH, including a 7-wicket victory in May 2024. At Wankhede, MI have traditionally dominated SRH, thanks in part to the familiarity with conditions and fans support.

Both teams currently hover in the mid-table zone, and a win here could be crucial in the jostle for playoff spots. MI, with momentum and home support, start as slight favourites, but if SRH's top order fires like it did last game, anything is

In 2024, smartphone exports from India to the US reached USD 7.03 billion, up from USD 4.7 billion in 2023. Exports to the UK rose to USD 1.5 billion, compared to USD 1.039 billion the previous year. At a media briefing on Tuesday,

The contract between GRSE and NPOL for the ARS was signed in October 2024. The 93 m long and 18 m wide ARS will be a very advanced platform, that will have a complement of 120 personnel and will be capable of speeds ranging from 4 knots to 12 knots. At top speed, the ship will have an endurance of 30 days or 4,500 nautical miles in a sin-

The capabilities of the ARS will include deployment, towing and retrieval of various equipment such as acoustic modules, carrying out temporal and/or spatial high-resolution surveys of sound velocity profiles and collection of ocean tides/current information to be used for survey optimization, design of underwater moorings and offshore deployments.

The research vessel will also carry out meteorological surveys to understand the influence of atmospheric parameters in sound propagation studies and undertake shallow water acoustic reverberation studies. It will also be capable of launching, mooring and maintaining standalone buovs and collecting data from them. Its wide speed range will allow the ship to operate at multiple speed regimes to carry out acoustic systems trials, while silence.The maintaining ARS will also have a dynamic positioning system that will allow it to maintain position in intact condition up to Sea State 4. The vessel will have diesel-electric propulsion and three (3) deck cranes will be fitted on board to handle research equipment. GRSE has necessary experience in the construction of research and survey ships. It delivered the first series of Sandhayak Class of Survey Vessels to the Navy in the 80's & 90s. In 1994, GRSE delivered the INS Sagardhwani. This is a Marine Acoustic Research Vessel
