PM Modi surveys flood-hit Punjab



Chandigarh: Prime Minister Narendra Modi began a crucial visit to flood-affected regions of Punjab and Himachal Pradesh today to assess the widespread damage caused by recent floods.

Arriving at Pathankot Airbase from Delhi, he proceeded by helicopter to conduct an aerial survey of the hardest-hit areas in Himachal Pradesh, including Kullu, Mandi,

The visit was briefly overshadowed by a bomb threat received via email by the principal of Nerchowk Medical College in Mandi, Dr DK Verma. Authorities swiftly evacuated the hospital, relocating approximately 300 patients to safety, and a police search operation is underway to secure the premises.

In Dharamshala, PM Modi will lead a

high-level meeting to review the disaster's impact, with a detailed presentation on the damage. Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu, who inspected preparations, will attend.

At 4 pm, the Prime Minister will meet flood victims in Tibbri, Gurdaspur, to address

Punjab's AAP government has sought Rs 80,000 crore in relief from the Centre, while Himachal has requested a special aid package. Punjab AAP president Aman Arora expressed hope for support, noting the Prime Minister's earlier "silence" on Punjab crisis.

On September 5, union Agriculture Minister Shivraj Singh Chouhan visited Amritsar, Gurdaspur, and Kapurthala, promising aid to affected communities



Relief for Flood-Hit Punjab, Additional Rs 12,000 Crore Under Central Schemes

Prime Minister Narendra Modi, after an aerial survey of flood-affected areas in Punjab, announced a Rs 1,600 crore relief package for the state, supplementing Rs 12,000 crore already allocated under central schemes.

In Gurdaspur, he met 19 farmers from areas like Fazilka and Ajnala, who raised concerns about unpaid 2023 compensation and issues like illegal mining and neglected Dhussi bandhs.

Modi assured a multipronged recovery plan, including rebuilding homes under PM Awas Yojana, highways, restoring reconstructing schools, and

providing PMNRF relief and livestock mini-kits. Advance releases of SDRF and PM Kisan Samman Nidhi funds were also promised. Punjab BJP chief Sunil

Jakhar noted the Prime Minister's 30-minute interaction with farmers, while leader Tarun Chugh highlighted local distrust in state fund distribution. Earlier, in Himachal Pradesh, Modi conducted an

aerial survey of Kullu, Chamba, Mandi, and announcing a Rs 1,500 crore financial assistance package, ex-gratia payments and met 18 victims, including oneyear-old Nitika, orphaned in a June 30 cloudburst.

PRadhakrishnan Elected Vice President of India



New Delhi: In a major victory for the National Democratic Alliance (NDA), C P Radhakrishnan was elected as the 15th Vice President of India on Tuesday. Radhakrishnan, the NDA candidate, secured a decisive victory over the Opposition's joint nominee, B Sudershan Reddy.

The election results revealed a significant win for Radhakrishnan,

who garnered 452 first-preference votes. His opponent, Sudershan Reddy, received 300 votes. According to Returning Officer P C Mody, out of the 788 eligible Members of Parliament (MPs), 767 cast their votes, resulting in a 98.2% turnout. Of these, 752 votes were deemed valid, while 15 were declared invalid.

PM Oli resigns amid escalating Gen Z protests; Senior officials appeal for restraint

Prime Minister KP Sharma Oli on Tuesday resigned from his post, amid the escalating Gen Z protests, that has left at least 19 youths dead and around 500 injured. President Ramchandra

Paudel has officially accepted PM Oli's resignation. Oli's resignation came unprecedenteddemonstrations led by Gen Z youths demanding accountability for corruption, government restrictions, and yesterday's police action in which 19 protesting youth were shot dead. The PM's resignation came as protesters vandalised several vital offices including the Parliament building, residences of top leaders and ministers, and the protests spread across other cities.

The protests escalated on Tuesday following outrage over yesterday's police action on the youths. Over 500 people were injured in clashes with security forces at various places, including the Federal Parliament in Kathmandu.

Nepalese authorities have imposed curfew across the Valley and deployed heavy security to manage the demonstrations, but the protests have continued to



widespread demonstrations. Officials expressed heartfelt condolences to the families of those who lost their lives and extended sympathy to the injured. "With the resignation of the Prime Minister KP Sharma Oli now accepted, we sincerely urge all citizens to remain calm and avoid further damage to life and property,"

the appeal stated. We also call on all concerned parties to seek a swift and peaceful resolution through political dialogue. The appeal was signed by

officials including: Eknarayan Aryal, Chief Secretary; Ashok Raj Sigdel, Chief of Army Staff; Gokarnamani Duwadi, Home Secretary; Raju Aryal, Inspector General Armed Police Force; and Chandra Kuber Khapung, Inspector General, Nepal Police. The officials emphasized that cooperation from citizens and restraint by all parties are critical to stabilizing the situation and preventing further casualties or property damage. Oli was serving his

fourth term as prime minister since July 2024 with the backing of the Nepali Congress. His resignation marks the end of a political career that saw him hold office in 2015-16, 2018-21, briefly in 2021, and again from July 2024 until his exit on Tuesday.

Known for his assertive style and nationalist policies, Oli had come to power on promises of stability and prosperity but left amid mounting unrest and accusations

authoritarianism. He was supposed to visit India later this month.

Minister Omar Abdullah today said that invoking the stringent Public Safety Act (PSA) against Doda MLA Mehraj Malik, while taking no action against those accused of "hurting people's sentiments" at Hazratbal shrine, is "not good

Omar said he failed to understand what Malik had done that warranted the government's decision to invoke the stringent PSA against him.

"Has the situation deteriorated anywhere? Was there any stone-pelting? On the contrary, the people who spoilt the environment here, the people who played with our religious sentiments and spoilt the environment in Hazratbal—there is nothing against them. Instead, innocent people are being harassed here. They are being called to police stations and questioned," Omar told reporters in Srinagar.

The Chief Minister said if



the MLA had made a mistake, it could be rectified under the supervision of the Speaker."A law like the PSA should not have been invoked against him. This will reduce the public trust in democracy," Omar

Referring to incidents earlier this year, Omar said on July 13, the martyrs' day, the administration made a mistake detained many leaders."On July 14, they made another mistake. They got me heckled by the police.

After that, arresting the MLA in the PSA is not a good thing. It is not a good thing for our democracy," Omar said. When asked about the election for 17th Vice-President, the Chief Minister questioned the Election Commission of India for keeping four seats of J&K in Rajya Sabha vacant and thereby denying the union territory its rightful representation.

'Our votes are already less, I don't understand. It's been nearly 11 months since our assembly elections. Why are the seats of our Rajya Sabha empty today? If we had four more votes, our voice would have been stronger. We would have been able to speak," Omar said.

"I don't understand why the Centre and Election Commission is taking revenge on us that our Rajya Sabha elections are not taking place," he add-

On the recent floods, Omar said he expects Jammu and Kashmir to be compensated for the losses suffered.

He further requested the union Railways Minister to run special trains to ensure movement of essential goods to Kashmir and transport fruit produce outside

Bhubaneswar: Bhitarkanika National Park in Odisha's Kendrapara district has reestablished itself as a congenial habitat of resident water birds maintaining a stable nesting population of nesting winged species, a senior official said today.

The official statistics of the annual colonial bird census released today pegged their population at 1,30,796 belonging to ten species. With this, the population of monsoon birds has increased marginally this year in comparison to 1,30,123 birds sighted in 2024.

"The consistent presence of diverse water bird species underlines the ecological importance of Bhitarkanika Mangroves as one of the largest heronries in Asia.

The annual nesting congregation not only enhances the ecological richness of the mangrove ecosystem but also provides critical insights into the conservation status of colonial water birds.

"The Mangrove Wildlife Division, Rajnagar, remains committed to ensuring the protection of wetland habitats and safeguarding the future of these avian species", said Divisional Forest Officer, Rajnagar Mangrove Wildlife Division, Varadaraj Gaonkar.

The census team moni-



tored all the water bodies and mangrove forest areas of Mathadia, Laxmiprasaddia, Durgaprasaddia and Balidia heronries in and around the Bhitarkanika national park.

The Asian Open-billed Stork continued to dominate the nesting colonies, with 15,919 nests, making it the most abundant species in the region. Other significant species include Black-headed Ibis, Purple Heron, Large Egret, Intermediate Egret, Little Egret, Grey Heron, Little Cormorant, Blackcrowned Night Heron, and

Among the heronry Laxmiprasad-Dia (13,594 nests) and Matha-Adia (13,261 nests) emerged as the major nesting hubs, contributing the bulk of the nesting population.

UP police launches campaign against illegal firecracker units in state

Lucknow Pradesh Police has launched a 15-day special campaign to curb incidents of explosions in illegal firecracker factories and warehouses across the state, police sources said

According to the police, they have launched this campaign following the instructions of Director General of Police (DGP) Rajiv Krishna. The campaign is being run under the supervision of ADG (Law and Order) Amitabh Yash.Under this, all licensed firecracker units will be inspected by joint teams of jurisdictional officers, sub-divisional magistrates, station in-charges and fire officers. "The inspections will be videographed and verified by senior officials including ADMs, SPs, DIGs, commissioners and district magistrates," sources said.DGP Krishna noted that it was extremely important to ensure fire safety preparedness, especially against chemical

BJD future seems uncertain as it abstains from VP poll Bhubaneswar:

decision on part of the Biju Janata Dal (BJD), the principal opposition party in Odisha, to abstain from 2025 Vice President poll has led analysts to believe that the regional party is steadily losing relevance almost 15 nationally, months after it lost power to BJP after 24 years of uninterrupted rule in the state.

BJD, headed by Naveen Patnaik, lost to BJP in both the 2024 Assembly polls and Lok Sabha polls. Patnaik, who never eyed pan-India expansion of the party, failed to check the BJP's electoral juggernaut after staying at the helm in the State for a record 24 years.

The party, which governed the state uninterruptedly from 2000 to 2024, suffered its worst poll debacle by drawing a blank in the 2024 Lok Sabha polls. It now remains content with 7 Rajya Sabha members with two of its elected members switching fences to BJP after the poll debacle and promptly re-elected to the Upper House on BJP ticket.

Speculation was rife that BJD which supported ruling NDA in several key issues in the past 11 years may vote in favour of IN-DIA bloc candidate for the VP poll being held today as several party stalwarts were in favour of such a move to reinvent itself to get rid of pro-BJP image following the electoral loss in 2024 twin polls. The move to abstain has

apparently dented the regional party's image. BJD's strength in both

the Houses was truncated after the Lok Sabha poll drubbing.

The party's Rajya Sabha strength has also been trimmed to seven after two MPs Sujit Kumar and Ma-



mata Mahant defected to the BJP and were promptly renominated by the saffron

Though the regional party lacked the numbers to stamp out a massive impact in the VP polls, casting vote for INDIA bloc rather than decision to abstain could have sent a message louder that the party does not serve the interest of ruling alliance at the Centre.

A social media post of Tathagata Satapathy, former BJD MP and editor of a leading Odia daily, that the regional party was resorting to self-destruction sums up steadily eroding political relevance of the regional party at least in national political scenario. "Odisha's Biju Janata

Dal (BJD), by deciding to abstain in the Vice Prez election, seems to have harakiried its total political existence whatever little remained", Satapathy, who quit active politics in 2019, stated in a post on X. The BJD move to ab-

stain from the VP poll has triggered an avalanche of adverse reaction in social media circles. Odisha Pradesh Congress Committee president Bhakta Charan Das slammed the BJD saying that BJD & BJP are two sides of the same coin and that Congress was the only opposition in Odisha and

BJD's decision to abstain from vote has proved it. This is nothing but a tacit endorsement of the

Naveen Patnaik has opted to protect himself rather than his party. Senior BJD leaders are clearly afraid of Central agencies breathing down their necks, he charged.

Even inside the BJD, unease is palpable. Several senior leaders privately admit that the abstention has dented the party's claim of being the principal opposition to the BJP in Odisha. "Had MPs been allowed a conscience vote, as during the Waqf Bill, many would have backed the INDIA bloc candidate," confided a veteran functionary. By choosing not to take

a stand, the BJD has once again left itself open to accusations of double-speak. Its assertion of "equidistance" looks increasingly hollow, as it has, over the past decade, sided with the BJP at the national level.

BJD's stand in the previous VP polls is varied. It abstained from the 2012 poll, in which Hamid Ansari won. It backed non-NDA candidate Gopalkrishna Gandhi in the 2017 poll, in which Venkaiah Naidu won. In 2022, it extended its support to NDA candidate Jagdeep Dhankhar.

JNU leopard scare: After 'hoax', officials stay on trail on campus; no signs found yet

New Delhi : In the wake of a leopard being allegedly spotted inside the Jawaharlal Nehru University (JNU) campus, forest department officials said on Monday that the possibility of the animal still being present has not been ruled out.

The claim of a leopard sighting sparked widespread panic among students and staff, leading to an immediate response from the authorities.

To monitor the situation, the forest department has installed one cage and four camera traps across the campus. These measures are aimed at confirming whether the big cat is indeed present.

So far, however, no pug marks, animal kills, or any direct evidence of a leopard have been detected. This has raised doubts over the authenticity of the initial sighting.

security incharge Naveen Yadav said, "The traps have not recorded any animal movement in the forest. However, as a precaution, the camera traps and cage will remain in place for some time.

The scare began last Friday when a student reported seeing a leopard perched on a tree behind the Kaveri hostel.

afterward, WhatsApp messages circulated among students, fueling panic. The messages claimed the sighting had been reported by a student from room number 15 of the hostel.

Later, it was clarified that the student mentioned in the viral message was visually impaired and had not raised any alarm. He denied the claims, describing them as misinforma-

Floodwaters Breach Ghaggar **Embankment**

in Sirsa Sirsa: Villagers in Sirsa district are living in fear as the Ghaggar river's fragile embankments continue to erode, threatening to submerge vast agricultural areas. Despite efforts by the administration to contain the damage, the river's strong current has so far overpowered them. Local residents, feeling abandoned by the authorities, have taken matters into their own hands, working tirelessly day and night to protect their homes and crops. Local leaders, including the sarpanches of Ranga, Thiraj, Mattar, and Lehngewala, have urgently requested more support, citing a lack of manpower and machinery like JCB machines and tractortrolleys. They claim that despite meeting with the Deputy Commissioner, Shantanu Sharma, last week and receiving assurances, no aid has arrived in their villages. In response, **Deputy Commissioner** Sharma has urged residents not to believe in rumors, stating that administrative and irrigation department teams are actively monitoring the situation and providing necessary resources. He praised the villagers for their cooperation. For the past three days, communities along the river have been on high alert. At Panihari, a damaged embankment remains unrepaired, causing water to flood fields in nearby Nejadela Kalan. Former sarpanch of Nejadela Kalan, Hoshiar Singh, warned that if the breach isn't sealed, the water could rise and threaten nearby hamlets. Currently, nearly 1,000 villagers are using whatever materials they can gather to try and fix the embankment. While water levels have slightly dropped at Sardulgarh,

War Injury **Pension Cannot Be Denied Based** on 'Disease' vs. 'Injury'

Chandigarh: The Punjab and Haryana High Court has ruled that the government cannot deny war injury pension to military personnel by distinguishing between a "disease" and an "injury" when both are suffered in an operational area. The Division Bench of Justice Harsimran Singh Sethi and Justice Vikas Suri made it clear that a soldier's posting in a counter-insurgency zone carries inherent risks, and any disability contracted there must be treated as a war injury.

The Union had argued that the soldier's eye condition, Interstitial Keratitis, was a disease, not an injury, and therefore he was not entitled to war injury pension. The court rejected this argument, stating that once a disability forces a soldier out of service, the distinction is irrelevant. The court noted that the soldier was posted in Jammu and Kashmir under "Operation Rakshak," which is officially clas-

Canal for Floods porary lakes, with no natural

Patiala: Punjab has once again found itself grappling with the aftereffects of heavy rains and swelling rivers, but this time, state officials are pointing fingers squarely across the border. In a series of strong remarks and statements, officials from Patiala and other districts have held Haryana responsible for obstructing the natural flow of the Ghaggar river and its tributaries. According to them, these disruptions have led to increased flooding in many border villages, particularly in Patiala district, where the impact has been severe and persistent.

The primary bone of contention is the Hansi-Butana canal, which has long been a flashpoint between the two neighboring states. Punjab authorities have reiterated that the canal was constructed without their consent or mandatory environmental and inter-state clearances. This unilateral move, they argue, has upset the delicate hydrological balance in the region, particularly during the monsoon season when rivers swell and need unhindered routes to disperse excess water.

During the devastating floods of 2023, the consequences of this alleged obstruction became painfully clear to residents of border villages like Samana, Sassi Brahman, and Dharmehri. Water levels rose rapidly, inundating homes, damaging infrastructure, and ruining standing crops. Local residents watched helplessly as their fields turned into temexit route for the water due to the canal's structure acting like a man-made dam.

The canal, which stands approximately twenty feet high, has become a point of serious concern for Punjab's flood management authorities. Rather than serving merely as a waterway, the structure's elevation has effectively created a barrier that prevents floodwater from flowing naturally into Haryana. This alteration in topography, though perhaps unintended, has turned into a long-term hydrological issue that Punjab can no longer ig-

Adding to the problem is the malfunctioning siphon under the Hansi-Butana canal, which was originally designed to allow the natural flow of water beneath the canal. However, officials have observed that the siphon is choked with silt and debris, significantly reducing its capacity to carry water through. This obstruction causes water to back up, overtop banks, and spill into adjacent villages on the Punjab side, triggering annual scenes of devastation during the rainy season.

A recent inspection by Harjot Kaur, the Sub-Divisional Magistrate of Patiala, brought renewed attention to the issue. Her site visit confirmed what many villagers and engineers had been reporting for years — that the canal, especially in its current neglected state, is a major contributor to the worsening flood situation in border vil-

Health Director and Two Others Face Forgery Charges

storm has begun to gather around the Haryana Health Department as its current Director, Dr. Manish Bansal, finds himself at the center of a forgery and criminal conspiracy case. The case, registered at the Fatehabad City police station, follows a judicial directive issued by Chief Judicial Magistrate Suyasha Jawa, and implicates not just Dr. Bansal but also two other officials. The allegations stem from a sequence of events that traces back several years but continues to raise questions about administrative conduct, abuse of power, and institutional in-

At the heart of the matter is a complaint filed by Dr. Sanjeev Kumar, a practicing doctor who runs a hospital in Bhuna, a town in Haryana's Fatehabad district. According to Dr. Kumar, the trouble began in 2017, during the period when Dr. Bansal served as the Chief Medical Officer. He alleges that a false case under the Medical Termination of Pregnancy (MTP) Act was lodged against him and his wife after they refused to comply with a demand for a bribe. This initial confrontation set off a series of legal and administrative complications that continue to echo in the present case.

The implications of a fabricated case under the MTPAct are grave, both professionally and personally. For Dr. Kumar and his wife,



tial threat to their medical careers and reputations. It took five long years for the couple to clear their names, culminating in their acquittal by a competent court in July 2022. That ruling not only brought some relief to the aggrieved couple but also laid the groundwork for Dr. Kumar's determined pursuit of Even before the acquit-

tal, in 2020, Dr. Kumar had taken the step of filing a complaint with the Chief Minister's Grievance Redressal System, commonly known as the CM Window. His complaint alleged wrongful an inquiry into the officials involved. It was intended to be a formal appeal to the state machinery to investigate potential misuse of power. What followed, however, was a sequence of events that he claims further deepened the injustice.

Dr. Kumar alleges that during the 2023 inquiry conducted in response to his CM Window complaint, his signature was forged by a clerk in an attempt to prematurely close the investigation. According to his version of events, an official document was prepared to indicate that he had voluntarily with-

drawn his complaint or was no longer interested in pursuing it. This document, bearing what purported to be his signature, was then sub-mitted as part of the internal review process.

Suspicious quickly and quietly the complaint had been closed, Dr. Kumar sought transparency through the Right to Information (RTI) Act. The documents he ob-

tained confirmed his worst fears: the statement that led to the closure of his complaint did, in fact, carry a forged signature. In a bid to strengthen his claims, Dr. Kumar had the signature examined by a fingerprint and handwriting expert. The expert's report validated the forgery and added a crucial evidentiary layer to the complaint that eventually made its way to the court.

The court, taking cognizance of the matter, acted decisively. Chief Judicial Magistrate Suyasha Jawa ordered that a case be registered, citing sufficient prima facie evidence to proceed with a police investigation. The charges under consideration—particularly forgery and criminal conspiracyare not only serious but could have long-term consequences for those involved if proven in court. For Dr. Bansal and the other two officials named in the FIR, this development marks the beginning of a legal process that could significantly impact their careers and public standing.

Health Teams Deployed to Flood-Affected Kurukshetra

Kurukshetra: In the wake of widespread flooding across Kurukshetra, the Health Department has mobilized a rapid and expansive response to safeguard public health in both rural and urban areas of the district. With waterlogged roads, submerged fields, and marooned households defining the current landscape, medical authorities have sprung into action to prevent the outbreak of waterborne and vector-borne diseases that often follow such natural disasters. This swift deployment of healthcare services is a vital component of the government's ongoing flood

relief operations. Since September 3, dedicated health teams have fanned out across the region, managing to reach over 230 villages and 17 municipal wards despite significant logistical chal-

The urgency of the situation has prompted the establishment of 151 health camps—temporary medical facilities offering basic treatment and consultations to residents who are otherwise cut off from regular healthcare access. These camps have already provided medical checkups and assistance to more than 2,000 people, many of whom are grappling with health issues directly linked to the flooding.

These health camps are not just offering routine consultations; they are functioning as critical checkpoints to monitor for symptoms of emerging health threats such as dengue, typhoid, gastroenteritis, and other communicable diseases. The most common ailments



identified so far include fever, skin infections, stomach-related illnesses like gastroenteritis, and eye infections such as conjunctivitis. These findings underscore the precarious health environment created by prolonged exposure to contaminated water and humid condi-

In addition to providing direct medical assistance, the Health Department is running intensive awareness campaigns to educate residents about essential hygiene and sanitation practices during

Teams are distributing oral rehydration solution (ORS) packets, educating families on the importance of hydration during episodes of diarrhea and vomiting, and promoting the boiling of drinking water as a vital preventive step. Public health workers are also stressing the importance of personal hygiene and cautioning against the use of stagnant floodwater for any domestic purposes.

A critical part of the department's preventive efforts includes water quality testing.

Of the 46 water samples collected and analyzed so far, 10 have been found to be unfit for consumption. This discovery has prompted further emergency chlorination of community water sources, such as wells and ponds, in an attempt to curb bacterial growth and make the water safer for everyday use. Authorities have urged residents to avoid using untreated water under any circumstances and to immediately report any signs of illness.

Logistically, the delivery of healthcare services to many of the flood-affected regions has posed serious challenges. In several areas, traditional modes of transportation have become unusable due to inundation, forcing health workers to adopt alternative methods. Medical teams are now traveling by tractor-trailers to access isolated villages, braving waterlogged roads and marshy terrain. This level of commitment speaks volumes about the urgency of the crisis and the frontline efforts to ensure no community is left without

Water Recedes in Markanda, **But Crop Damage Remains**

Kurukshetra: the water level in the Markanda river has finally started to recede after days of flowing above the danger mark, the situation for local farmers remains dire. The river caused extensive waterlogging in the Shahabad and Pehowa areas, and thousands of acres of paddy and sugarcane crops are still sub-

merged. According to data, 3,951 farmers from 200 villages in Kurukshetra have filed claims for losses on the e-



kshatipurti portal, with over 23,540 acres of land reporting damage. Shahabad is the most affected area, followed by Pehowa. Local farmers expressed concerns that the soil deposited by the floodwaters has badly damaged their crops, and they face heavy losses. The discharge in the river is now below the danger level, but agricultural fields remain flooded. The Deputy Director of

Agriculture for Kurukshetra, Dr. Karamchand, estimated that more than 10,000 acres have suffered a 50-100% loss. Local MLA Mandeep Chatha has called on the government to find a permanent solution to prevent annual flooding, such as deepening the riverbed and building stronger embankments.

Court Upholds Right to Refuse Promotion

Chandigarh: In a landmark ruling, the Punjab and Haryana High Court has asserted that police personnel cannot be forced to accept a promotion against their will. The court rejected the state's argument that Constables must become Head Constables, stating that promotion is a choice, not a compulsion.

The "strange case," as the court described it, involved Haryana police offi-



cers who challenged an order that included them in a list

for the Lower School Course—a prerequisite for promotion to Head Constable. The officers, all over 35, told the court they did not want to be promoted and were willing to forgo any financial benefits associated with the higher rank. The state, citing a shortage of Investigating Officers, argued that Constables were obligated to accept the promo-

Haryana CM Sanctions Reserve Fund for Flood Relief

Chief Minister Nayab Singh Saini has taken swift action to address the devastation caused by the recent floods. announcing the sanction of a ₹3.26 crore reserve fund for immediate relief operations across the state.

The fund is aimed at providing emergency support to residents in flood-affected areas and will be used for the distribution of essential supplies such as food, clothing, temporary shelter, and fodder for livestock.

It will also cover transportation needs and facilitate drainage work in rural regions where standing water continues to pose serious health and logistical risks.

The Chief Minister, during his official statement, conveyed deep sorrow over the loss of 13 lives caused by house collapses linked to the flooding. To support bereaved families, the government has approved an ex gratia compensation of ₹4 lakh for each deceased individual, totaling ₹52 lakh. In addition, injured persons have received financial assistance of ₹2 lakh each to help them manage treatment and recovery costs.

As floodwaters wreak havoc on agriculture, the economic backbone of rural Haryana, the state government is also prioritizing compensation for crop losses. Over 2.53 lakh farmers



have so far registered their claims through the state-run e-kshatipurti portal, which was launched to streamline the process of damage reporting. Officials are actively verifying these claims, and the government has committed to disbursing compensation of up to ₹15,000 per acre, depending on the extent of loss.

CM Saini acknowledged the wide-ranging impact of the floods, not only on people and crops but also on homes and infrastructure. Relief camps have been set up in multiple districts to accommodate those displaced by the disaster. The administration is also conducting

detailed surveys of homes that have been fully or partially damaged to ensure that the affected families are listed for assistance and reha-

Health concerns following the floods have taken center stage as well, prompting the Chief Minister to issue a public advisory. He has urged residents in affected areas to consume only boiled water to reduce the risk of water-borne diseases.

Emphasizing the need for hygiene and sanitation during this critical period, he also asked people to maintain cleanliness around their homes to prevent infections such as dengue and malaria.

The funds and measures announced are part of a broader response strategy by the Haryana government to minimize the long-term consequences of the flooding. State officials, in coordination with local administrations and health departments, are working around the clock to ensure the timely delivery of aid, restoration of essential services, and monitoring of public health indi-

Fatehabad DC Transfer Sparks Community Outcry

of Fatehabad's Deputy Commissioner has sparked widespread discontent among local communities, with sarpanches from at least eight villages uniting in protest against the move. In a strongly worded appeal to Haryana Chief Minister Nayab Singh Saini, the sarpanches have demanded an immediate reversal of the decision, citing the DC's crucial role in managing flood relief and waterlogging crises in the district. The Deputy Commissioner, who had been actively engaged on the ground during the recent floods, earned widespread appreciation for her direct involvement in relief distribution, coordination of rescue efforts, and communication with villagers. According to the protesting sarpanches, her visible presence in submerged areas provided both logistical support and a morale boost to residents facing displacement, damaged homes, and loss of liveli-hoods. They warned that transferring her during this period of ongoing distress would severely disrupt the pace and coordination of relief efforts. The villages that have formally signed the letter of protest include Noor Ki Ahli, Khumbar, Malwala, and others, each of which has been grappling with the aftermath of heavy rainfall and the resulting canal breaches. The sarpanches emphasized that in times of crisis, consistent leadership is critical, and sud-

While the community support for the DC appears strong, the transfer has also stirred a political debate. The timing of the decision has led to speculation that it may have been influenced by political pressure. Many believe that the action stems from a complaint lodged by Fatehabad Congress MLA Balwan Singh Daulatpuria, who had recently taken to social media to criticize the Deputy Commissioner for alleged negligence following a canal breach that caused flooding in one of the villages in his constituency. Daulatpuria's criticism centered on what he claimed was a lack of preparedness and slow response in the wake of the canal breach

According to him, administrative inefficiency had allowed the situation to worsen, affecting hundreds of residents. Following his remarks, the DC's transfer was announced, a move he has publicly defended, stating that accountability in governance must be upheld, especially during emergencies. However, local leaders and residents have pushed back against this narrative, accusing the MLA of politicizing a humanitarian crisis. In their letter to the Chief Minister, the sarpanches called the transfer "untimely and detrimental" to ongoing recovery efforts.

that such political interference could demoralize field officers and deter other officials from taking decisive action during emergencies out of fear of repercussions. The controversy has highlighted the friction that often arises at the intersection of administration and politics during times of crisis. While elected representatives are expected to ensure that public officials are held accountable, many argue that performancebased decisions must be made with objectivity and in consultation with local stakeholders, especially when the stakes are high. This episode also underscores the crucial role that district-level officers play during disaster response. For residents of flood-hit villages, the DC was not just a bureaucrat but a visible authority figure who brought direction and urgency to the government's relief machin-

Her coordination with health teams, public works departments, and local volunteers helped maintain a semblance of order amid the chaos. Since the announcement of the transfer, there has been visible unrest in parts of Fatehabad, with villagers holding meetings, putting up banners, and even considering a collective petition drive. Haryana Achieves Second Rank in **National Anaemia Eradication Campaign**

Gurugram: Haryana has made significant progress in its fight against anaemia, securing the second position nationally in the first quarter of the year. This marks a notable leap from its eighthplace ranking last year. The National Health Mission's latest report, part of the Anaemia Mukt Bharat (Anaemia-Free India) project, shows that Haryana's score of 85.2 points places it just behind Andhra which scored 88.0. The state's success is attributed to its extensive implementation of the '6x6x6' approach, which targets six key age groups with six different interventions through

six institutional mechanisms.

This approach includes ironfolic acid supplementation, iron-fortified foods, and screening and treating anaemia in schools and communities. The state also used an IT platform to track beneficiaries under the ATAL (Assuring Total Anaemia Limit) Abhiyan. The report highlights Harvana's success in reaching 77% of children aged six to 59 months, 95% of children aged five to nine, 95% of adolescents, and 93% of pregnant women. However, coverage for lactating mothers was lower at 65.9%, an area the state plans to address to become 100% anaemia-free. Looking ahead, Haryana plans to intensify its focus on

lactating mothers by strengthening community health outreach and integrating anaemia screening with postnatal care visits. Additional training and incentives for healthcare workers, better supply chain management of supplements, and targeted communication campaigns are also on the cards. As Haryana stands just a few points behind the national leader, the possibility of becoming the top-ranked state in anaemia control seems within reach. With its structured approach and community-driven model, Haryana's example may well shape the next phase of India's fight against nutrition-

nificant move aimed at advancing women's economic participation and strengthening cooperative institutions in the state, Haryana Chief Minister Nayab Singh Saini has directed the implementation of major policy changes focused on gender inclusion and rural development. Chairing a high-level review meeting of the Cooperation Department at the Civil Secretariat in Chandigarh, the Chief Minister underlined his government's commitment to empowering both farmers and women through cooperative reforms.

At the heart of this initiative is a bold directive mandating that 50 per cent of all Vita milk booths be reserved for women. The Chief Minister stressed that this reservation is not symbolic but a concrete effort to ensure economic self-reliance among women, particularly those in rural and semi-urban areas. He instructed officials to identify suitable locations for these booths at the earliest, so that allotments could begin without delay.

The move is part of a larger strategy to utilise cooperative models as engines of socio-economic development. CM Saini said that cooperatives have historically played a vital role in improving livelihoods in rural India, and it is time to modernise and expand their impact. By creating space for women within these structures, the government hopes to enable inclusive economic participation and financial indepenIn line with this vision,

the Chief Minister called for the rapid formation and operationalisation of Women Primary Agricultural Credit Societies (PACS). These women-run cooperatives are expected to offer a platform for rural women to engage in agricultural and allied activities, access credit, and build community-level financial networks. He emphasised that such institutions could serve as crucial tools for organising rural women and integrating them into the formal economic system. Another focus of the

meeting was the need to bring Haryana's cooperative banks in sync with modern technological advancements. CM Saini directed that all cooperative banks across the state be equipped with state-of-the-art IT infrastructure. Additionally, the health and well-being of the public remained on the CM's agenda. He directed officials to ramp up efforts to expand the network of Jan Aushadhi Kendras across the state. These centres, which offer quality generic medicines at low cost, should be established near hospitals and other health institutions to increase accessibility. The Chief Minister said that this would not only reduce the financial burden on families but also reinforce the healthcare delivery system in underserved areas.

The Chief Minister's emphasis throughout the meeting was on speed and scale of implementation. He urged officials across departments to work in coordination and ensure timely execution of all proposed schemes and reforms. Delays, he warned, would undermine the government's objectives of transparency, inclusion, and grassroots empowerment.

The broader message emerging from the meeting was clear: the state government intends to push forward with reforms that are peoplecentric, digitally enabled, and inclusive of women. By linking financial support systems, health access, and rural cooperative infrastructure under one integrated framework, Haryana is aiming to create a robust and responsive model of rural gover-

Flood Fury Derails Learning in Sirsa: Online Classes **Struggle Amid Power Cuts and Poor Connectivity** Sirsa: As floodwaters

continue to batter large swathes of Sirsa district, the education of schoolchildren has become yet another casualty in the growing list of disruptions. With villages inundated and roads turned into rivers, the district administration has issued a temporary closure order for all schools, forcing a sudden transition to online education. But the shift, meant to ensure continuity of learning, has run into significant obstacles of its

The idea of moving classes online sounds practical on paper, especially when physical access to school buildings is neither safe nor feasible. But on the ground, the story is one of frustration, interrupted lessons, and unequal access to education. Power outages have become a daily norm in the flood-hit areas, and for many children, this means no internet, no charged devices, and no access to their classes. Rural and semi-urban families in particular are finding it nearly impossible to maintain any semblance of a learning schedule.

On Monday, several private schools across Sirsa tried to adapt quickly, launching online classes for students of different grades. But these efforts were hampered by the realities of life in a disaster zone.

Power cuts lasting hours and erratic network

signals meant that even students who were eager to attend couldn't participate fully. Some logged in late, others were dropped from sessions repeatedly, and many didn't manage to con-

Seerat, a fifth-grade student at a well-known private school, was among those left disappointed. "I really wanted to attend class today," she said. "But there was no electricity in our area the whole morning. My phone battery was dead, and there was no Wi-Fi." Her story is echoed in dozens of homes, especially in the countryside where infrastructure is weaker and restoration work slower.

In the flood-affected village of Jhorarnali in Rania block, Parth, a Class X student, explained how helpless he felt as his devices remained uncharged due to the blackout. "There's no power at all here," he said.

"I couldn't even switch on my phone. There's no way to attend online school unless the electricity returns." His concern is particularly serious, given that students of his age group are approaching crucial academic assessments.

Aerika, a third-grade student residing in urban Sirsa, said she missed her regular classroom environment. "I really enjoy being in school with my friends and teacher," she said. "Online learning is hard. But my exams are coming, and I have to study somehow." Despite her young age, Aerika's sense of responsibility is clear, but even her determination can't over-

come the technical barriers. Parents are standing behind the district administration's decision, acknowledging that safety must take precedence over academics during such a crisis. Richa, Aerika's mother, said that while online classes are not ideal, she fully supports the closure of schools. "In these conditions, no one can guarantee children's safety if they go out. The roads are dangerous, and water is everywhere," she said. "Let schools remain closed until the situation improves.'

Avinash Mehta, father of two school-going children, echoed similar sentiments, emphasizing the physical risks involved in commuting right now. "It's not just about water on the streets," he pointed out. "There are open electric wires, dug-up roads for drainage, and a high risk of short circuits. One mistake could lead to disaster. At least at home, we can monitor the kids and keep them safe."

Meanwhile, school administrators are doing what they can to keep students connected and engaged, even in these tough circumstances. Rajeev Utreja, the principal of DAV Centenary Public School, confirmed that his institution had completed most of the academic syllabus ahead of the floods and that students had gone through revisions.

But with the administration announcing official off days, the school was compelled to postpone the

half-yearly exams. 'We are in touch with our teachers and students through digital platforms as much as possible," Utreja explained. "Once schools reopen and attendance normalizes, we will revise the syllabus again and then announce fresh exam dates." The principal emphasized that student safety remains the school's number one concern and that reopening decisions will be strictly aligned with government directives.

This unexpected disruption has once again highlighted the digital divide that exists between students in urban centers and those in remote, underserved areas. While some students in town areas may have access to smartphones. Wi-Fi, and backup power solutions, many in rural pockets are completely cut off, making any form of online education unattainable for now.

The flooding, which has already taken a heavy toll on agriculture and infrastructure in the district, is now threatening to derail academic progress for thousands of children.

While schools and families are doing their best to adapt, the situation has made it clear that emergency education systems need to be better equipped to handle natural calamities, especially in districts vulnerable to seasonal flood-

Murdochs reach deal in succession battle over media empire

New York : A yearslong succession battle within Rupert Murdoch's conservative media empire has drawn to a close, with his son Lachlan set to control the news group.

The deal, which the family announced on Monday, will ensure the ongoing conservative leaning of Fox News, The Wall Street Journal and The New York Post even after 94-year-old Rupert's death, reports BBC.

Under the agreement, Lachlan will control a new trust while siblings Prue MacLeod, Elizabeth Murdoch and James Murdoch will cease being beneficiaries of any trust with shares in Fox or News Corp.

It follows years of tension between the media mogul and three of his children over the future of the family-owned newspapers and television networks. Lachlan is currently the

chair of News Corp, which counts The Wall Street Journal and The Times among its slew of publications. He is widely seen as the most politically conservative of Rupert's oldest children

Lachlan's more politically moderate oldest siblings are poised to sell their holdings in Fox and News Corp in the coming months. They will also be named as beneficiaries of a new trust, which will receive cash from the sale of about 14.2 million shares of News Corp. and 16.9 million shares of Fox Corp.

The sale of their shares will add to the three siblings' existing inheritance, but prevent them from having any influence over the political bent of the family's media conglomerate.James has in recent years distanced himself from his family's business, citing disagreements over editorial content.Of Rupert's six children, the oldest four

have been implicated in the legal turmoil over the company's future. His younger children from his marriage to Wendi Deng Murdoch, Chloe and Grace, are also named as beneficiaries in the new family trust.He wanted to ensure his empire would fall solely into Lachlan's hands rather than to all four of oldest children, but in December last year a Reno court rejected that bid saying Rupert and Lachlan had acted in "bad faith" in trying to amend the trust. Monday's deal was a "mutual resolution of the legal proceedings", according to the companies.
