## PM Modi surveys flood-hit Punjab



**Chandigarh**: Prime Minister Narendra Modi began a crucial visit to flood-affected regions of Punjab and Himachal Pradesh today to assess the widespread damage caused by recent floods.

Arriving at Pathankot Airbase from Delhi, he proceeded by helicopter to conduct an aerial survey of the hardest-hit areas in Himachal Pradesh, including Kullu, Mandi,

The visit was briefly overshadowed by a bomb threat received via email by the principal of Nerchowk Medical College in Mandi, Dr DK Verma. Authorities swiftly evacuated the hospital, relocating approximately 300 patients to safety, and a police search operation is underway to secure the premises.

In Dharamshala, PM Modi will lead a

high-level meeting to review the disaster's impact, with a detailed presentation on the damage. Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu, who inspected preparations, will attend.

At 4 pm, the Prime Minister will meet flood victims in Tibbri, Gurdaspur, to address their concerns.

Punjab's AAP government has sought Rs 80,000 crore in relief from the Centre, while Himachal has requested a special aid package. Punjab AAP president Aman Arora expressed hope for support, noting the Prime Minister's earlier "silence" on Punjab crisis.

On September 5, union Agriculture Minister Shivraj Singh Chouhan visited Amritsar, Gurdaspur, and Kapurthala, promising aid to affected communities.



### Relief for Flood-Hit Punjab, Additional Rs 12,000 Crore Under Central Schemes

Prime Minister Narendra Modi, after an aerial survey of flood-affected areas in Punjab, announced a Rs 1,600 crore relief package for the state, supplementing Rs 12,000 crore already allocated under central schemes.

In Gurdaspur, he met 19 farmers from areas like Fazilka and Ajnala, who raised concerns about unpaid 2023 compensation and issues like illegal mining and neglected Dhussi bandhs.

Modi assured a multipronged recovery plan, including rebuilding homes under PM Awas Yojana, highways, restoring reconstructing schools, and

**New Delhi:** In a major victory for the National Democratic Alliance (NDA), C P Radhakrishnan was elected as the 15th Vice President of India on Tuesday. Radhakrishnan, the NDA candidate, secured a decisive victory over the Opposition's joint nominee, B Sudershan Reddy.

The election results revealed a significant win for Radhakrishnan,

who garnered 452 first-preference votes. His opponent, Sudershan Reddy, received 300 votes. According to Returning Officer P C Mody, out of the 788 eligible Members of Parliament (MPs), 767 cast their votes, resulting in a 98.2% turnout. Of these, 752 votes were deemed valid, while 15 were declared invalid.

## Congress stakes claim to legislative council opposition leader's post

Mumbai: With the of Leader of Opposition (LoP) in the Maharashtra Legislative Council falling vacant after the end of Ambadas Danve's tenure, the Congress has staked its claim to the position.

The party is citing its numerical strength in the Maha Vikas Aghadi (MVA) alliance, and Congress Legislative Council group leader Satej Patil is likely to Thackeray at his residence, be appointed if the claim is accepted.

For the first time in the history of the Maharashtra Legislature, both Houses the Assembly and the Council—are without a Leader of Opposition. Amid this backdrop, senior Congress leaders Balasaheb Thorat, Vijay Wadettiwar, and Amin Patel met Shiv Sena (UBT) chief Uddhav

Matoshree, to discuss the current political situation and the vacant posts.

During the meeting, the Congress proposed that the Assembly LoP post be given to the Thackeray while faction. the Legislative Council post should go to the Congress. In the Council, the Congress holds the largest number of seats within the MVA, with eight seats, compared to six for the Shiv Sena (UBT) and two for the NCP (Sharad Pawar faction).

The meeting also touched upon the possibility of an alliance between the Shiv Sena (UBT) and the Maharashtra Navnirman Sena (MNS). Wadettiwar said the matter would be discussed with the party's central leadership before taking a final stand.

## Maharashtra Cabinet approves agricultural and urban development projects

Maharashtra Cabinet, led by Chief Minister Devendra Fadnavis, today approved projects worth thousands of focusing agricultural and urban development.

The meeting sanctioned an extension of electricity tariff subsidies for 1,789 lift irrigation schemes across the state until March 2027, affordable ensuring electricity for members of farming cooperative societies.

#### Maha Revenue Dept allocates land for IB's residential quarters in Panvel

The Maharashtra Cabinet, chaired by Chief Minister Devendra Fadnavis, on Tuesday approved the allocation of 4 hectares of grazing land in Mauje Asudgaon, Panvel, District Raigad, to the Subsidiary Intelligence Bureau (SIB), Mumbai Division. This will enable the construction of modern residential quarters for SIB officers and employees, strengthening national security infrastructure in the region.

According to the revenue department release, the aligns with the provisions of Sections 22A and 40 of the Maharashtra Land Revenue Code, 1966, Rules 5, 6, and 50 of the Maharashtra Land Revenue (Distribution of Government Land) Rules, 1971, Government Notification dated March 15, 2018, Government Circular dated December 14, 1998, and Section 51(1)(c) of the Maharashtra Gram Panchayat Act, 1958. The land has been granted to the Deputy Subsidiary Intelligence Bureau, Government of India, Mumbai

Division, as 'Occupant Class-2' with lien and possession, subject to the prescribed terms and conditions.

The allotment is based on an assessment amount of 50 per cent of the value calculated at the non-cultivated rate, as per the current rapid census.

The Revenue Department, headed Chandrashekhar Bawankule, remains committed to facilitating strategic infrastructure projects that support national agencies while ensuring compliance with state regulations and promoting the welfare of officers and employees serving the nation, said the release.

Meanwhile, the cabinet also approved the provision of expenditure for the repair of Ghonga and Kanadi minor irrigation schemes in Murtijapur taluka of Akola district. A provision of Rs 4.76 crore was approved for the repair of the Ghonga project and Rs

4.92 crore for the Kanadi project. The work of the Ghonga Micro Irrigation Scheme was completed in

1986. The work of the Kanda Kanda Micro Irrigation Scheme was completed in 1977. The pitching of both these projects has not been repaired, trees and bushes have grown in the canal, and the service road on the project has not been repaired.

For this, the expenditure was approved as a special matter for the repair of both these projects. Due to this repair, an additional 35 thousand cubic meters water storage and 45 hectares of irrigation capacity will be created. The original water storage of this project is 1550 thousand cubic meters, and the original irrigation capacity is 350

As far as the repair of the Kanadi project is concerned, it will create an additional 38 thousand cubic meters of water storage and 46 hectares of irrigation capacity. The original water storage of this project is 1700 thousand cubic meters, and the original irrigation capacity is 286 hectares, said the government release.

Minister Omar Abdullah today said that invoking the stringent Public Safety Act (PSA) against Doda MLA Mehraj Malik, while taking no action against those accused of "hurting people's sentiments" at Hazratbal shrine, is "not good for democracy.

Omar said he failed to understand what Malik had done that warranted the government's decision to invoke the stringent PSA against him.

"Has the situation deteriorated anywhere? Was there any stone-pelting? On the contrary, the people who spoilt the environment here, the people who played with our religious sentiments and spoilt the environment in Hazratbal—there is nothing against them. Instead, innocent people are being harassed here. They are being called to police stations and questioned," Omar told reporters in Srinagar.

The Chief Minister said if



the MLA had made a mistake, it could be rectified under the supervision of the Speaker."A law like the PSA should not have been invoked against him. This will reduce the public trust in democracy," Omar

Referring to incidents earlier this year, Omar said on July 13, the martyrs' day, the administration made a mistake detained many leaders."On July 14, they made another mistake. They got me heckled by the police.

### Odisha Bhitarkanika emerges as major heronry for colonial birds

Bhubaneswar: The Bhitarkanika National Park in Odisha's Kendrapara district has reestablished itself as a congenial habitat of resident water birds maintaining  $a\,stable\,nesting\,population\,of$ nesting winged species, a senior official said today. The official statistics of

the annual colonial bird census released today pegged their population at 1,30,796 belonging to ten species. With this, the population of monsoon birds has increased marginally this year in comparison to 1,30,123 birds sighted in 2024.

'The consistent presence of diverse water bird species underlines the ecological importance of Bhitarkanika Mangroves as one of the largest heronries in Asia.

The annual nesting congregation not only enhances the ecological richness of the mangrove ecosystem but also provides critical insights into the conservation status of colonial water birds.

"The Mangrove Wildlife Division, Rajnagar, remains committed to ensuring the protection of wetland habitats and safeguarding the future of these avian species", said Divisional Forest Officer, Rajnagar Mangrove Wildlife Division, Varadaraj Gaonkar.

The census team moni-



tored all the water bodies and mangrove forest areas of Mathadia, Laxmiprasaddia, Durgaprasaddia and Balidia heronries in and around the Bhitarkanika national park. The Asian Open-billed

Stork continued to dominate the nesting colonies, with 15,919 nests, making it the most abundant species in the region. Other significant species include Black-headed Ibis, Purple Heron, Large Egret, Intermediate Egret, Little Egret, Grey Heron, Little Cormorant, Blackcrowned Night Heron, and Darter.

Among the heronry es, Laxmiprasad-Dia (13,594 nests) and Matha-Adia (13,261 nests) emerged as the major nesting hubs. contributing the bulk of the nesting population.



They also urged the state to consider dovecotes where real eggs can be swapped with dummy ones to humanely reduce the pigeon population, a method widely used in Europe.

PETA India maintains that these methods respect Mumbai's cultural ties with pigeons while prioritizing public hygiene and safety.

"With the right approach, Mumbai can preserve its traditions while practicing compassion," said Garg. Meanwhile, the BMC's move has divided public opinion—some citing health concerns, others backing PETA's call for humane

### Al with Green Energy

I have not taken any money. I have not taken even a single rupee from any mandal or neta. Jiya Gopalani and Ulhas Falke are falsely framing me." In his bail plea, Borde

denied the allegations, describing the suicide note as "vague and omnibus." The plea argued that since the deceased, her husband, and daughter are all advocates, they would have produced the note immediately if it were authentic.

"The note appears to be an afterthought, fabricated to falsely implicate the applicant," the bail plea

However, advocate Purshottam Khanchandani alleged that Borde and others systematically harassed his wife over a property dispute, claiming they illegally encroached on government land and attempted to seize part of her property.

The objection claimed that the accused "deliberately created an atmosphere of fear and pressure, instigating Sarita to take the extreme step." It further alleged that they used "political clout" to intimidate her.

After hearing arguments from both sides, the court reserved its order.



Sambhaiinagar: The Marathwada region has recorded 128.2 per cent of its normal rainfall for the June to September period, with a total of 722.2 millimetres (mm) against the average of 679.5 millimetres, according to the daily rainfall analysis released by the Revenue Department.

Beed district recorded the highest rainfall at 153.9 percent of normal, receiving 686.0 mm against the average of 566.1 mm, according to data released at 10.06 am this morning. Between June and August, Beed received 478.9 mm, which is 121.5 percent of the normal 394.1

However, September rainfall remained low at just 9.3 mm, which is only 18.0 percent of the monthly normal of 51.6 mm.

Jalna district followed with 145.1 percent of normal rainfall, recording 730.9 mm against the normal 603.1 mm. From June to August, the district received 543.8 mm, 117.9 percent of the normal 461.3 mm. In



September, it received 37.8 - 88.9 percent of the normal 42.5 mm, with 3.8 mm recorded on the report-

Nanded district reported 115.2 percent of normal rainfall, with 803.0 mm against the normal 696.8 mm. Though not officially banned, it is facing obstacles and indirect restrictions, with distributors and exhibitors under pressure," the letter stated. The producers, according to IMPPA, are encounter-

ing resistance from theatre

owners and distributors who

fear law-and-order issues.

The association alleged that

the West Bengal government



has failed to ensure a conducive atmosphere for public screenings, thereby denying audiences their constitutional right to choose what to watch."Crores of rupees have been invested in the making of this film. Blocking its release will not only cause irreparable financial losses to

producers and distributors but also send a chilling signal to filmmakers across India," IMPPA warned. The association reminded that under the Cinematograph Act, once a film has been cleared by the CBFC, no state government can unilaterally stop its exhibition unless law-and-order

fied and addressed through due process. This controversy echoes earlier disputes surrounding politically sensitive films. West Bengal had previously denied screenings of 'The Kerala Story' in 2023, while 'The Kashmir Files' too faced stiff resistance in certain quarters before the Centre stepped in to ensure wider release. Both cases triggered heated debates over freedom of expression, political sensitivities, and the powers of state governments vis-a-vis certified works of art.Industry observers note that the latest episode is part of a recurring pattern where films with political or historical narratives face roadblocks in select states despite central certification. The ÎMPPA has framed this as a test case for the credibility of the CBFC and the uniformity of film distribution rights across India.Calling for immediate intervention, IMPPA urged the Prime Minister to uphold the sanctity of certification and protect filmmakers' rights. ### Rachel second Vanuatu player with T20I fifty and hat-trick

Suva (Fiji): Vanuatu captain Rachel Andrew delivered a record-breaking allround performance as her side narrowly defeated Indonesia by seven runs in the opening match of the ICC Women's T20 World Cup East Asia Pacific Qualifier, being held in Fiji.

The win marked a memorable start to Vanuatu's campaign for a spot in the 2026 ICC Women's T20 World Cup Global Qualifier.

Rachel, 27, played a pivotal role in both innings. With the bat, she anchored Vanuatu's innings, scoring an unbeaten 85, the backbone of the team's total of 131. Her innings was marked by controlled strokeplay and aggressive finishing, enabling Vanuatu to post a competitive score.

However, it was with the ball that Rachel etched her name in cricket history. She claimed a hat-trick, finishing with figures of 3/10, becoming only the second Vanuatu player to achieve the feat in Women's T20 Internationals. Rachel also became the



second player globally for Vanuatu to combine a fifty and a hat-trick in a single T20I match, replicating a rare achievement earlier recorded by her national teammate Selina Solman, who scored an unbeaten 56 and took 4 wickets for no runs against France earlier this Indonesia had begun

their run chase strongly, with openers Maria Corazon and Desi Wulandari putting together a 55-run opening stand. But the Vanuatu bowlers, particularly Rachel and Nasimana Navaika, turned the match in Vanuatu's favour. Navaika contributed with three crucial wickets for 27 runs in her quota of four overs, complementing Rachel's hat-trick, and restricting Indonesia to 124

Rachel's performance earned her the Player of the Match award and highlighted her allround cricketing prowess. With this victory, Vanuatu are placed second in Group B after the opening round of matches, behind

Stadium while Bolivia fell 3-0 to Colombia in Barranquilla in the penultimate round of qualifiers last Thursday.

Ancelotti admitted Brazil would adopt a different game plan in the rarefied air of the Municipal Stadium in El Alto, on a plateau overlooking the capital, La Paz.

## Murdochs reach deal in succession battle over media empire

New York: A yearslong succession battle within Rupert Murdoch's conservative media empire has drawn to a close, with his son Lachlan set to control the news group.

The deal, which the

family announced on Monday, will ensure the ongoing conservative leaning of Fox News, The Wall Street Journal and The New York Post even after 94-year-old Rupert's death, reports BBC.

Under the agreement, Lachlan will control a new trust while siblings Prue MacLeod, Elizabeth Murdoch and James Murdoch will cease being beneficiaries of any trust with shares in Fox or News Corp.

It follows years of tension between the media mogul and three of his children over the future of the family-owned newspapers and television networks.

Lachlan is currently the chair of News Corp, which counts The Wall Street Journal and The Times among its slew of publications. He is widely seen as the most politically conservative of Rupert's oldest

Lachlan's more politically moderate oldest siblings are poised to sell their holdings in Fox and News

Corp in the coming months. They will also be named as beneficiaries of a new trust, which will receive cash from the sale of about 14.2 million shares of News Corp. and 16.9 million shares of Fox Corp.

The sale of their shares will add to the three siblings' existing inheritance, but prevent them from having any influence over the political bent of the family's media conglomerate.James has in recent years distanced himself from his family's business, citing disagreements over editorial content.Of Rupert's six children, the oldest four

have been implicated in the legal turmoil over the company's future. His younger children from his marriage to Wendi Deng Murdoch, Chloe and Grace, are also named as beneficiaries in the new family trust.He wanted to ensure his empire would fall solely into Lachlan's hands rather than to all four of oldest children, but in December last year a Reno court rejected that bid saying Rupert and Lachlan had acted in "bad faith" in trying to amend the trust. Monday's deal was a "mutual resolution of the legal proceedings", according to the companies.
